		1.2	Any Bid submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Bid by UNDP. UNDP is under no obligation to award a contract to any Bidder as a result of this ITB.
		1.3	UNDP reserves the right to cancel the procurement process at any stage without any liability of any kind for UNDP, upon notice to the bidders or publication of cancellation notice on UNDP website.

3. DESCRIPTION OF THE DAMAGE

-The Building has not damaged directly but the basement floor of the 3rd joint was fully burned which include all Rooms and corridors and Baths W.C, and it was rehabilitated these building, and now in this phase complete the rehabilitation works for W C units and teaching staff rooms and supply furniture for the hall rooms, library halls and Teaching staff rooms.

4. WORKS ON BRIEF:

The rehabilitation work includes civil, Sanitary and Mechanical and Electrical works and supply furniture in the library and study halls and teaching staff.
