UNDP is under no obligation to award a contract to any Bidder as a result of this ITB. UNDP reserves the right to cancel the procurement process at any stage 1.3 without any liability of any kind for UNDP, upon notice to the bidders or publication of cancellation notice on UNDP website.   - b) Were involved in the preparation and/or design of the programme/project related to the goods and/or services requested under this ITB; or
  - c) Are found to be in conflict for any other reason, as may be established by, or at the discretion of UNDP.
- 4.2 In the event of any uncertainty in the interpretation of a potential conflict of interest, Bidders must disclose to UNDP, and seek UNDP's confirmation on whether or not such conflict exists.
- 4.3 Similarly, the Bidders must disclose in their Bid their knowledge of the following:
