### **Description of the assignment:**

Recognizing the fact, urbanization has been haphazard and unplanned in the recent years in the urban areas of Nepal with the existing risk, have led in intensification of disaster impact. Disaster incidences have increased however the mechanism to cope with these disasters have not been operationalized with proven measures and model at local level, even the local level have different capacities in terms of human and financial resources. With the aim, to create a shared understanding on urban disaster risks and evolve mechanisms and measures that can aid the communities and municipal governments to address different dimensions of vulnerabilities and risks and effectively respond to emergencies, with specific focus on the vulnerable population. UNDP is currently implementing a project, "Reducing disaster risks and enhancing emergency response capacities in multi hazard-risk prone urban areas of Nepal" in three local level, two being Lalitpur and Bharatpur metropolitan city whereas other one is Bhimeshwor Municipality representing cities across Nepal with the funding support from EU/ECHO.

Formulation of DRRM Act and Local Governance Operation Act, under the Constitution of Nepal 2072, it has been recognized that local governments are the prime state authority to take care of the disaster related affairs including formulation of local level DRRM Act and ensuring any other necessary arrangements. However, the local governments in place, while they are yet to fully internalize DRRM, are still under capacitated hence, there is urgency to strengthen this system to ensure effective and coordinated humanitarian response. Further to this, urban core areas have undergone significant change in morphology, density, demography and usage of spaces, there is higher accumulation of risk that can trigger any crisis anytime. Urban growth is happening in haphazard manner with development activities being undertaken without accounting the underlying hazards and risk factors. There is lack of understanding of extant hazards, level of its possible impact and account of vulnerable population, that adversely affects emergency response.

On to other side, communities in urban settings also have several capacities to respond to crisis, however the primary roles of these extant capacities have yet not been explored sufficiently to prepare a joint and coordinated response at community, ward and metropolitan/municipal level. During 2015 earthquake it was also observed that specific needs of vulnerable communities, households, sections of populations – Person with Disability (PWDs), elderly, women and children identified required tailored approach to meet their specific needs. In addition to this, the vulnerable section including the geographical regions across the country demands for region specific disaster relief standards in absence of which relief efforts are either largely insufficient, uncoordinated or even overlapped.

Against this background, this proposed assignment ensures to link identified key at risk areas, vulnerable population and their needs, recognizing the existing mechanisms, capacities and gaps of department and sections within the municipalities including identification of extant capacities including of private

sector leading to formulation of a well-coordinated emergency preparedness and response plan addressing the needs of vulnerable section of local level.

This assignment will also provide technical assistance in development and operationalization of municipal level disaster relief standards and guidelines. While formulating the relief standards and guidelines national and cluster specific guidelines and standards will be considered along with global standards like Sphere standards, Core humanitarian standards, humanitarian principles, where needs of vulnerable groups are explicitly considered and spelled out. The assignment also envisions to address DRRM related gaps at municipal and at-risk communities through preparedness plans along with relief standard which will facilitate the relief distribution in different crisis event triggered from multiple hazards.

The main aim of this assignment is to set foundation for coordinated and effective disaster response by respective metropolitan/municipalities which will directly contribute to create one common understanding on humanitarian response and relief in a foundation of a robust preparedness. The overall objective of this proposed assignment is to support in preparation of an Emergency Preparedness and Response Plan (EPRP), and relief standards and guidelines for project metropolis and municipality. The specific objectives of the assignment are as below.

- To prepare EPRP with clear set of standard operation procedures, trigger, benchmarks and coordination mechanism for functionality of division and sections under the respective Metro/NPs for managing disaster incidents along with clear division of roles and responsibilities for all division and sections including Ward Disaster Management Committees (WDMC), task forces, private sectors, volunteers and other stakeholders.
- To prepare Metropolis/Municipal level humanitarian relief standards and guideline to set common actions among the stakeholders for post disaster relief management and guide emergency readiness including stockpiling.
- 3. To prepare table top simulation guideline for testing and updating EPRP on regular basis.

### 4. Scope of work

The overall scope of this assignment is to:

- 1. Facilitate consultative meetings, workshops and take lead in collection of key information required for preparation of EPRP and relief standards/guideline with all relevant and key stakeholders from national to local level including vulnerable population.
- 2. Explore existing gaps, potential ways to fill up the gaps through wider consultation with the stakeholders/participants.
- Identify and assign roles and responsibilities to division, section within Metro/NPs to respond during emergency and accordingly assign specific responsibilities to individuals from respective departments and sections.
- 4. Review current Gender & Social Inclusion including disable, senior citizen, children approach in the Metro/NPs and analyze these in relation with the EPRP and relief standard and guidelines as inputs.
- 5. Propose standard framework for preparation of EPRP supported by preparedness improvement plan and relief standard and guideline.
- 6. To outline coordination mechanism with internal and external critical service providers and other stakeholders/agencies for effective response.
- 7. Validation of EPRP with consultation from Municipal authorities and stakeholders
- 8. Carry out a desk top test of the EPRP in the metro/NP focusing on its activation driven by triggers.

The expert will be called upon to perform a specific list of tasks defined in accordance with any of the above enlisted objectives and scope of work.

Deliver outputs as per the specific objectives defined above, and in the manner prescribed. The key deliverables of this assignment are:

- 1. Emergency Response and Preparedness Plans for Bharatpur and Lalitpur Metropolitan City, and Bhimeshwor Municipality in Nepali.
- 2. Relief standards and guidelines for its application for post-disaster relief distribution and management including emergency stockpiling.
- 3. Prepare generic simulation guidelines with injects to test and update EPRP.
