the required letter to secure visas, given that the situation is not as clear as now due to COVID but also due to recent development in the Israeli-

REPLY No. 3: The strength of the proposal is very much reliant on the qualifications of

QUESTION No. 4: Regarding the references of one previous similar experience, do you need

certificates now for eligibility?

REPLY No. 4: Yes, a proof shall be submitted in the form of a contract and/or a certification

of completion.

QUESTION No. 5: Should we provide methodology or short approach at this stage?

REPLY No. 5: No.

QUESTION No. 5: Regarding the criteria of one project of similar nature, please explain what you

mean by similar nature_ in terms of the services that would be provided by

JAIP/PICDEC or the type of phase zero specific kind of services?

REPLY No. 5: Project of similar nature should be understood in broader terms as there are

based on our knowledge not many similar exercises in the Country, where an entity is required to prepare for management of agro-business and/or industrial zone. We will therefore allow the applicants to assess their own projects and assess if one/more in some aspects can be related to the activities within this specific project. What UNDP want to see if the justification of why experience gained through the previous project has relevance for the applicant's management of this one. Moreover, due to the lack of previous similar projects in the Country we will give more attention to the profile of the company/consortium and the suggested management entity. The determination will be made mainly on that level, because local organizations do not have quite close similar experience in the past.

QUESTION No. 6:

Regarding the required expertise in the ToR, one of the expertise is Marketing and IT expert; can we submit one CV in Marketing and another in IT? is there an option to have more than one CV for the expertise of different areas?

REPLY No. 6:

As long as we get both Marketing and IT expertise the composition of personnel and their individual skills are not set in stone. Hence, we don't worry about having one or two individuals covering that.

Further to add, the evaluation panel will look into the key personnel in aggregate; means we will look into the combination of expertise, skills, number of years to determine whether the provided team collectively meet our minimum requirements. Please see attached the revised version of the IPQ.

The qualification requirement of the Team Leader is more stringent; we require higher number of years of experience (15 years). Marketing and IT are (10) years and the rest of the team are (5) years. Though we will show flexibility; as it is not the number of years alone, but most importantly the demonstrated skills and experience. Hence we will consider the combination of proven experience, skills and years.

QUESTION No. 7: With regards to the joint venture, consortium or association, do you want financial data for the lead entity or each member of the consortium/joint venture?

REPLY No. 7: The financial data is required from the lead entity/ prime applicant.

QUESTION No. 8: With regards to the (10) years of required experience (eligibility No. 7 page 8 of 26); is it related to the firm? is this for the lead entity or each member of the

consortium/joint venture?

REPLY No. 8: Eligibility No. 7 page 8 of 26 of the IPQ document is related to the Applicant,

meaning that this requirement is only applicable to the lead entity/ prime

Applicant in case the Applicant is a joint venture or consortium.

QUESTION No. 9: If there is change in the legal registration of the entity, means re-established

again, will you count previous years?

REPLY No. 9: Yes, we will. We will look into the combination of both experiences and total

years (old and newly established entity) given there is a justification why there

is halt or change in the business activity.

QUESTION No. 10: Can the local consortium partner be a new company if the director has the

requisite experience?

REPLY No. 10: The Prime Applicant shall have min. (10) years of experience. The consortium

partner can be a younger firm – hence, less than 10 years of operation.

QUESTION No. 11: Is the role of the service provider basically just to institutionalize the center at

this point and any further activities are going to be included in the follow up

tender?
