#### **GENERAL INFORMATION**

Services/Work Description: International Firm Level Consultancy - Consultation with relevant

parliamentary committees in National/State legislatures in Nigeria, Cameroon, Niger and Chad to support the implementation of the Regional Stabilization Strategy (RSS) of the Lake Chad Basin

Commission (LCBC).

Project/Program Title: Lake Chad Stablization Facility

**Duty Station:** Home-based with possible travel to Nigeria, Cameroon, Chad and

### I. BACKGROUND / RATIONALE

The link between security, humanitarian and development issues around the Lake Chad Basin has led to an intractable extremist insurgency since 2009 that has killed tens of thousands of people and displaced an estimated 2.5 million people. To date, more than 10 million people in the Lake Chad Basin, particularly the northern and far north regions of Cameroon, Hadjer Lamis and Lake provinces in Chad, the Diffa region in Niger and the states of Borno, Yobe and Adamawa, are affected and in urgent need of assistance. In response to this threat, United Nations Security Council Resolution 2349 (2017) was adopted, followed by a series of high-level conferences, including the Oslo Advisory Group on Prevention and Stabilization conference in the Lake Chad region, held in Berlin, calling for strengthening regional collaborative capacity to address the crisis and the African Union and Lake Chad Basin Commission conference on developing a framework for a regional stabilization.

In the context above and to address the root causes of the conflict and ensure the long-term stabilization of the region, a regional strategy for stabilization, recovery and resilience (RSS) of the Lake Chad Basin areas affected by Boko Haram, was adopted by the Council of Ministers of the Lake Chad Basin Commission in August 2018 and approved by the African Union Peace and Security Council (CSC-AU) in December 2018.

UNDP has set up a Regional Stabilisation Facility for Lake Chad ("the Facility") as a contribution to supporting the RSS and is aimed at securing a step-change in the scale and nature of intervention around Lake Chad, in terms of speed and flexibility of response, increased territorial coverage, and improved regional cooperation. The Facility acts as a rapid-response mechanism that relevant authorities can sequence with military operations as necessary, to ensure immediate follow-up in specific locations that curtails the ability of Boko Haram to re-infiltrate and exploit any security vacuum or community perceptions of non-responsive Government, by extending an organized and effective civilian security umbrella and by consolidating military progress with development 'dividends' for the local population. The Facility has two specific objectives:

- 1. Immediate stabilization of insecure areas, where few actors are currently working, and where communities remain vulnerable to continued infiltration and attack
- 2. Extended Stabilisation: Support to LCBC and AU implementation of the RSS as a coherent and coordinated overarching framework for cross-border cooperation and multi-partner intervention in the region, aimed at long-term stabilization and steady transition from the provision of humanitarian assistance to development and resilience

Several of the activities envisaged to secure the outputs necessary to immediate stabilization are already being implemented by UNDP or other actors. The facility aims to increase effectiveness by delivering them together as a package, rapidly and flexibly, in more vulnerable areas where such assistance is currently piecemeal or absent.

The Facility is distinct from but does help to address the RSS, including the overall capacities of LCBC as well as specific PILLARS including pillar 5 (Governance & Social contract), pillar 6 (socio-economic

recovery and environmental sustainability), pillar 8 (PVE) and pillar 9 (empowerment of women and inclusion of youth). As noted above, through extended stabilization, the Facility will also support the establishment and operationalization of the structures required within the RSS including the Steering Committee which oversees the implementation of the Strategy, cross border cooperation mechanisms including the Governors' Forum, Civil Society Forum and Private Sector Forum. The Secretariat established at LCBC which has some functions including knowledge management, regional communication and technical advisory roles to set up the structures to implement the nine (9) pillars of the RSS including through Territorial Action Plans (TAPS).

To manage the Lake Chad Basin Inter-Parliamentary Advisory Committee (IPAC) in support of the implementation of the RSS, the RSS Secretariat is looking for an International firm. Under the overall guidance and direct supervision of the Coordinator/Head of Stabilisation Secretariat and the Inter-Parliamentary Advisor, the firm will; (1) identify parliamentary committees relevant to the implementation of the RSS, (2) engage National legislatures on the setting up of the IPAC.

### II. OBJECTIVES OF THE SERVICE / WORK

The main objective of the project is to carry out consultations with the relevant parliamentary committees of the national and state legislatures in Nigeria, Cameroon, Chad and Niger on the reactivation of the LCBC Inter-Parliamentary Advisory Committee and the organization of the First LCBC Inter-Parliamentary Forum.

#### III. SCOPE OF THE SERVICE / WORK

Based on the main objective, the institution or firm is expected to deliver the following; Desk Review of National/State Parliaments, Parliamentary Committees and their relevance to the different Pillars of the RSS;

- 1. Engagement of Parliamentary Committees and Former IPAC Members at National Levels;
- 2. Reactivation of IPAC and Organization of First LCBC Inter-Parliamentary Forum.

### IV. EXPECTED OUTPUTS / DELIVERABLES

The duration of the assignment is expected to be spread between July to December 2020 and the following outputs and deliverables are expected.

### V. METHODOLOGY / APPROACH OF THE SERVICE (WORK)

The firm is required to use both primary and secondary sources to gather information for this project. The firm will be expected to consult the Regional Strategy for the Stabilization, Recovery & Resilience of the Boko Haram-affected areas of the Lake Chad Basin (RSS), national constitutions, scientific journals, reports, newspapers and the websites of the different legislatures to gather data necessary for the identification of relevant parliamentary committees across national/state legislatures. Primary sources for information will be comprised of direct interviews with salient members of the relevant parliamentary committees and former members of the IPAC on the objectives, composition, governance and management of the LCBC Inter-Parliamentary Committee.

### VI. LOCATION, DURATION AND TIMEFRAME OF THE WORK /DELIVERABLES/OUTPUT

This consultancy assignment will be home-based. Travel to Nigeria, Cameroon, Niger and Chad for consultations with the parliamentarians and stakeholders of the different national and state legislatures will be required if security and safety conditions of COVID 19 within the different countries permit. #### VII. INSTITUTIONAL ARRANGEMENT / REPORTING RELATIONSHIPS

Under the overall guidance and direct supervision of the Senior Advisor and Head of Stabilization, the firm shall carry out a desk study on the parliamentary committees relevant to the implementation of RSS across legislatures of the four countries, the identify key parliamentary committees relevant to the implementation of the RSS and engage these committees in the setting up of IPAC and support in the planning and organization of the First LCBC Inter-Parliamentary Forum. The RSS Inter-Parliamentary Advisor will be the focal point for the firm for the overall delivery of the tasks. The firm shall submit deliverables at the end of each major task to the RSS Inter-Parliamentary Advisor. The final deliverable shall be submitted by 10<sup>th</sup> December 2020.

#### **VIII. PAYMENT MILESTONES AND AUTHORITY**

The prospective firm or institution will indicate the cost of services for each deliverable in US dollars all-inclusive<sup>1</sup> lump-sum contract amount when applying for this consultancy. The consultant will be paid based on the effective UN exchange rate (where applicable), and only after approving authority confirms the successful completion of each deliverable as stipulated hereunder. - It must have at least ten years of practical experience in governance, management and leadership preferably have a lot of engagements with the non-for-profit sector and UN agencies;
- Knowledge of relevant sectors and access to stakeholders and relevant information sources, especially of the Lake Chad region;
- Experience working with the UN or other international organizations is beneficial;
- Capability to deploy strong analytical aptitude, communication and presentation expertise;
- Capability to deploy good communication expertise in English and French languages;
- Certification from an accredited institution recognized by the UN;
- It shall demonstrate its capabilities, understanding of the TOR, and methodology of audit approach.

  - a. Technical Criteria weight is 70%
  - b. Financial Criteria weight is 30%
