ATTACHMENT 1- ANSWERS TO QUESTIONS FROM PROSPECTIVE PROPOSERS

Question 1: Are the firms registered outside of Turkey eligible for this RFP?

Answer 1: The firms registered anywhere outside of Turkey are also eligible to submit a proposal for this RFP.

Question 2: Are offshore based services from outside of Turkey acceptable?

Answer 2: With reference to the Detailed Terms of Reference, the project is based in Ankara, Turkey, and all experts shall perform their duties in Ankara, Turkey. The offshore services will not be accepted.

Question 3: Is there any pre-bid meeting/conference for this RFP?

Answer 3: Pre-bid conference will not be conducted, the proposers can contact via email for any queries related to this RFP.

Question 4: Can you provide phone number of the contact person to ask for clarifications?

Answer 4: As per the RFP, only written inquiries will be responded by UNDP receipt via email or official letter to the address or e-mail address of the contact person identified by RFP.

Question 5: Can you provide phone number of the contact person to ask for clarifications?

Question 6: With reference to qualification criteria, it is stipulated as “The Proposer must have a minimum average annual turnover of TRY 650,000 for the last 3 years. (2015,2016,2017)”. The years indicated in parenthesis contradict with the criteria. Please clarify?

Answer 6: The years in the parenthesis was written incorrectly. As per the criterion, the average annual turnover criterion is for the last three years, i.e. 2017, 2018, 2019.
