A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared.

The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component. The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR). Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. Sf = 1000 x Fm / F, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected subject to positive reference checks on the consultant's past performance.

Interview with the candidates may be held if deemed necessary.

1. Background

The Criminal Records Law was adopted by the National Assembly on 17 June 2009 and came into effect on 1st July 2010. The Law has provided the legal framework for developing the national database of criminal records, responding to the requirements of the management of the criminal records database and issuance of criminal record certificates. The Law also assured the human right for people to have their crimes expunged and reintegrate into the community so that they can take part in social activities, such as applying for a job or working license in some areas, going to work abroad. After 10 years of implementation, it appears that some provisions of the Law are not consistent with recently enacted laws such as the Penal Code and the Criminal Procedure Code. Therefore, it is necessary to assess

¹ From the day of the implementation on the Criminal records Law (1st of July 2010) to December 2019, over 3,300,000 criminal record certificates were issued whilst the period from 2010-2015, the number of people applying for their certificates and having criminal records is 0.05%. However, from 2015 until now, this number has gained to around 3%.

implementation of the Law with a view to proposing appropriate amendments in the coming time.

One of the important contents of the Criminal Records Law is the stipulations of the responsibilities of authorities which manage the criminal records database regarding updates to the information on criminal records of offenders. If the offenders have reached the conditions to have their crimes expunged stipulated in Article 70 of the Penal Code 2015², in case they request for their criminal records certificates, the managing authorities must grant them their certificates with the content "No previous crimes". This confirmation of the certificates is the legal foundation that considers these people as not having been sentenced.

The Penal Code 2015 (amended in 2017) (clause 4 Article 70)³ stipulates the responsibilities in managing, updating information on conviction expungement of offenders has made it difficult and challenging for the management of criminal records. The new mission in the Penal Code 2015 stipulates all managing authorities must verify the conditions of conviction expungement where offenders have reached the standard of time to be expunged in the Penal Code. The greatest difficulty in verifying the conditions is to verify whether or not the offenders have had new criminal activity during the period they are having criminal records (have they been prosecuted, investigated due to their new criminal activity?) Meanwhile, the current database only manages and stores information on criminal record, including criminal judgments and its enforcement. The current database does not include information on new criminal procedures (information on prosecution, investigation procedure...). It takes much of time to verify new criminal activities since the verification must be done with a variety of authorities in many places (investigative authorities, Procuracy ...), which affects the benefit of applicants for criminal record certificates.

In such context, under the EU Justice and Legal Empowerment project (EU JULE), UNDP and the Ministry of Justice National Center for Criminal Records (NCCR) commission a team of one international consultant and two national consultants to conduct **Empirical study to assess 10 years of implementation of the Criminal Records Law, focusing on the expungement of criminal records** (hereinafter referred to as "the study"). The outcome of this study is expected to provide a comprehensive assessment in order to establish a strong foundation for the future proposing the amendments of the Criminal Records Law.

The is collaborating with it is necessary to review the 10-year implementation of the Law, both the legal framework and its enforcement.

² Article 70 of the Penal Code 2015 stipulates: Offenders will have their crimes expunged if since when they finished executing their main punishments or their probationary period, they have finished executing additional punishments, other decisions of judgements and **have not had new criminal activity** during the period considered to have crimes expunged in this Penal Code.

³ The managing authorities of Criminal records database are in charge of updating criminal information of offenders and when they request for their criminal records certificates, they managing authorities must grant them their certificates with the content "No previous crimes" if they have had all the conditions to have their crimes expunged according to the Penal Code.

2. Objectives

- To review 10 years of implementation of the Criminal Records Law and assess relevant provisions on criminal expungement of the Criminal Records Law, the 2015 Penal Code and the 2015 Criminal Procedure Code, both the legal framework and its enforcement, using various research methodologies, such as desk review, interviews with relevant officials, practitioners and beneficiaries in the field.
- To identify the advantages and challenges of implementing of the Criminal Records Law and relevant laws in practice, including to those concerning substantive and procedural issues of the existing policies and regulations, focusing on the criminal expungement issue.
- To propose specific recommendations for MOJ to amend the Law and relevant provisions and improve the law enforcement.

3. Scope of work

The study will be carried out by 2 national consultants and 1 international consultant hired by UNDP in cooperation with MOJ NCCR.

a) National Consultant -Team leader (30 days)

General tasks:

- Take ultimate responsibility for the final report;
- Take the lead in discussions and responsibility for the whole process of the assignment with UNDP and NCCR;
- Cooperate closely with team member and international consultant; stay in close touch with UNDP and NCCR during the process of completing the assignment.
- Lead the group discussions and interviews at Ha Noi and 3 provinces (Hai phong, Thanh Hoa, Khanh Hoa) for the study and develop the reports about criminal expungement issues, include:

 - + Interview people who request criminal record certificates to assess the procedures of issuing the certificates and challenges they might face related to the criminal expungement (estimation of 10-15 people/1 province).
