THE MAIN REQUIREMENT IS THAT COMPANY SHOULD BE REGISTERED IN UKRAINE FOR AT LEAST THREE YEARS. HOWEVER, IF YOU WOULD LIKE TO APPLY AS CONSORTIUM OF UKRAINIAN AND FOREIGN COMPANY, YOU SHOULD REMEMBER THAT QUALIFICATIONS OF BOTH COMPANIES SHOULD BE SIMILAR AND MEET THE REQUIREMENTS. THE CONTRACT CAN BE SIGNED WITH THE MAIN COMPANY OF THE CONSORTIUM THAT SHOULD MEET THE REQUIREMENT OF AT LEAST THREE YEARS OFFICIAL REGISTRATION IN UKRAINE. <del>MAIN SHOULD BE FROM UKRAINE. THEREFORE, THE BIDDER SHOULD GUARANTEE THE SUBMISSION OF OPEN SOURCE DOCUMENT FOR THE EVALUATION. <del>UNDP HAS TO EVALUATE EXPERIENCE OF THE COMPANY AND SPECIALISTS.
