A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared.

The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component. The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR). Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. Sf = 1000 x Fm / F, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

<u>Submission obtaining the highest weighted points (technical points + financial points) will be selected</u> subject to positive reference checks on the consultant's past performance.

Interview with the candidates may be held if deemed necessary.



#### B. Description


On the ground in about 170 countries and territories, the United Nations Development Programme (UNDP) works to eradicate poverty while protecting the planet. UNDP helps countries develop strong policies, skills, partnerships and institutions so they can sustain their progress. UNDP – Viet Nam partnership officially started in 1978. Since then, UNDP has been working closely with the Government and other partners to expand the choices for people and ensure that everyone has equal access to opportunities to realize their full potential.

In recognition of the increasing complexity of our world, businesses as usual approach won't be enough to tackle the wicked sustainable problems we have today. UNDP set out in 2019 to build the world's largest and fastest learning network on wicked sustainable development challenges. The Accelerator Labs Network (AccLab) was introduced globally to the UNDP system for the first time to provide a paradigm shift in development. 60 labs globally are challenging the status quo by combining social innovation with sustainable development. UNDP is doing development differently because the speed, dynamics, and complexity of today's challenges are fundamentally different from even twenty years ago. We are creating a new capability for decision makers to explore, experiment, and grow portfolios of mutually reinforcing solutions to tackle today's challenges.



AccLab provides a suite of innovation approaches for UNDP partners and communities such as systemic design, collective intelligence, solutions mapping, experimentation, and more to offer. The lab work centre around tackling on-the-ground sustainable development issues through a Learning Cycle. One example is that by leveraging lean experimentation, the team tested current answers to social issues, the hypothesis of the ideal states, then came up with the optimal solution, backed by data and evidence within a much shorter time frame compared to traditional approaches.

The Accelerator Lab in Viet Nam was one of the first labs to be set up in the world. In 2019, the team reached certain achievements in Da Nang in the areas of waste segregation, with the cooperation of Da Nang's Department of Natural Resource (DONRE); and Danang City Night Lab, an initiative that aim to run by the Da Nang government, with the first feasibility report completed. Part of these works has been blogged and could be accessed via this <u>link</u>.



In 2020, the team aims to further expand the impact by stepping in additional areas, both in terms of works and geography. Across Viet Nam, the areas will include: (1) Circular Economy/ Waste – making our planet green again from the circular economy approach, (2) Public sector innovation – developing government capacity for anticipatory, agile and adaptive governance, and (3) Private Sector Acceleration – engaging businesses to align with SDGs.

The Accelerator Lab Viet Nam is seeking a team of national consultants/ innovation coordinators to support the team to establish and coordinate a network of social innovation practitioners, members of this community would be call **Labbies**.

# C. Vision for Viet Nam Accelerator Lab Community (VALC) - social innovation community of practice to share knowledge, collaborate on projects for sustainable development problem

This is a community engagement platform to flexibly engage with social innovators to collaborate, map solutions and share knowledge. The aim is to not start a network from scratch, but rather building on existing communities that are relevant to social innovation and sustainable development. The network format allows members from other networks to join, pursue their own objectives and be facilitated by the Lab toward a common agenda. The Lab role here is that of a partner that facilitates knowledge sharing, connectors and mobilize resources. Some existing community with relevance to Lab work:

- Universities (e.g. National Economic University, Hanoi University of Science & Technology...)
- Co-working spaces (The Learning Hub, TOONG, UP...)
- Youth-led organization (e.g.: AIESEC, Youth+, ASEAN Youth Organization, Youth Union...)
- NGOs/IGOs (e.g: GreenHub, WWF...)
- Social enterprise (e.g. KOTO, Tohe, Grapevine, Will to Live etc...)
- and many more...

For the **Volunteers (Labbies)**, the value proposition for joining the network can be summarized as follow:

- Access to innovation methods like solutions mapping, collective intelligence, experiment, systemic design, and given concrete opportunities to apply these in project/activities settings. These are very unique sets of skill and experience that they are unlikely to receive elsewhere.
- Conduct Solution mapping and ethnographic field research. Undertaking journey to engage with community to identify solutions for sustainable development problem
- Receive coaching and mentorship directly from Lab heads that can enable them to develop professionally and expand their horizon.
- Connect with like-minded people and work together on development issues.
- A flexible working commitment, that allows them to offer what they can and ask for what they need. For those who wish a more official arrangement, they will be given the opportunity to join UNDP as UNV or interns.
- much more to discover...

Labbies who join the network will get the chance to work with many interesting projects from Accelerator Lab and other units in UNDP such as Youth Co:Lab and Impact Aim. Some examples of the kind of work labbies can volunteers to:

#### Youth Co:Lab:

- Joining the research team for the National research into assessment and projection of resilience and adaptation of youth for entrepreneurship and impact business development, support to increase the numbers of responders
- Support to promote the Youth Co:Lab competition among young entrepreneurs of Viet Nam
- Support to design and spread the online SDG Entrepreneurship course
- Collaborate with UNDP communication consultants to design a webpage of Youth Co:Lab on UNDP Viet Nam website.

#### Impact Aim:

- Collaborate with the Impact Aim Project Coordinator, build the framework for Impact Aim Viet Nam
- Support to design and create content for Impact Aim website and facebook page
- Support to organize 2 events of Impact Aim in 2020: Introduce the Impact Mapping and the Impact Measurement framework

#### D. Scope of Work for the VALC Coordinating team

The main objective of the **VALC coordinating team** is to support the Accelerator Lab team in establishing and coordinating a team of labbies. We envision *Labbies* to be a team of young passionate changemakers who wish to develop their creativity and skills by solving local sustainability issues. The Labbies team will work closely with Viet Nam Accelerator Lab and can get

access to knowledge, resources and relationships of the UNDP global network. They will be able to develop professionally in the field of social innovation and sustainable development, the Lab and coordinator will be mentoring the labbies to help them develop to their fullest potential. Labbies will get the opportunity to work hands-on in innovative projects in UNDP such as Impact Aim, Youth Colab, Circular economy portfolio, etc... .The tasks of the coordinator include but not limited to the following list:

#### **Establish Labbies Network:**

- Assemble and inspire a team of volunteers to apply their creativity and skills on tasks from AccLab. The Labbies network is envisioned to work closely with Accelerator Lab on day to day basis
- **Design and organize a Bootcamp for VALC** to help establish a volunteer team, provide direction roles and team spirit. Furthermore, this is aimed to help volunteers build necessary skills for working professionally with Accelerator Lab and other partners.
- Coordinate Labbies create an enabling environment for them to ensure tasks completion and professional growth. The Labbies team will be working closely with Accelerator Lab on dailybasis. They will be handed tasks to complete in support of UNDP work, tasks will come from Accelerator Lab ongoing projects and workflow. Labbies will have the opportunities to learn the latest cutting-edge innovation methodologies, develop their professional skills and network.

#### **Promote Accelerator Lab work in Viet Nam**

- **Localizing communication materials** for the Accelerator Lab's works in Vietnamese, designing contents, and help with the physical distribution or promoting on online social media platforms.
- Organize Accelerator Lab Launch event to showcase the Lab approach and values in Viet Nam.
- **Develop a community of social innovation practitioners**. Inspire and empower participants to learn about innovation/ sustainability in their lives. Support to localize international innovation practice into Vietnamese context (e.g. Circular Economy, Foresighting, Design Thinking, Lean experimentation, Solution mapping, Art of Hosting etc...)

We are looking for people who have a proven track record of starting, designing and managing activities for the changemakers community. People who understand the sustainability challenge and are passionate about finding solutions to achieve 17 SDGs, ultimately making our society more environmentally and socially sustainable.

#### E. Expected Outputs and Deliverables

The following deliverables are expected to complete latest by 30 December 2020 by Community Director:

The Community Director (team lead) responsibility is to manage and oversee the setup and operation of VALC and Labbies members

- 01 Concept Note of VALC. Work together with AccLab Heads to design VALC vision and team structure with Accelerator Lab team.
- At least, 01 VALC Bootcamp Organized. The Boot Camp for will help establish a volunteer team, provide direction roles and team spirit. Furthermore, this is aimed to help volunteers build necessary skills for working professionally with Accelerator Lab and other partners. Labbies to basic social innovation and sustainable development concepts.
- 01 Team of Labbies is established through the 1<sup>st</sup> Bootcamp co-hort. Support Accelerator Lab team in assemble and recruit a team of Labbies which include local volunteers and later can be granted internships with UNDP.
- 01 Enabling Workspace for Labbies established. The team lead needs to arrange a suitable workplace arrangement for Labbies volunteer to work This will include things such as proposing a suitable workspace accommodation (e.g. a co-working space...) for the labbies

- team to work together and remotely, establishing a communication channel (Slack, Teams...) and team task management system (e.g. Trello...).
- Support Accelerator lab team in organizing Social Innovation Festival. For Accelerator Lab 1year anniversary, we are organizing an Social Innovation Festival, which is an exhibition and
  social gathering in celebration of Viet Nam social innovation ecosystem. Where we bring
  together innovators from all walks of life to showcase local solutions that can contribute to
  SDGs. This event will happen in Q3/4 of 2020, depending on COVID situation.
- Coordinate with the Accelerator Lab team to facilitate day-to-day tasks completion with Labbies in line with projects from Accelerator Lab. Ensure Labbies team have what they need (logistic, information, supplies etc...) to complete the tasks.

# The following deliverables are expected to complete latest by 30 December 2020 by Lead Learning Designer

- Work together with team lead to create an enabling environment for the VALC. The
  facilitator Is mainly responsible for developing the content of the program and deliver the
  training.
- Design the curriculum for a Lab Social Innovation Bootcamp. Develop learning tracks for VALC to learn about Sustainable development, Project skills, and self-development. The Bootcamp will equip Labbies the needed skills to work on sustainable development projects.
- At least 02 workshops or webinar are conducted monthly and should attract at least 20 people for each event. Develop contents for community workshops together with AccLab team. The Learning designer is to facilitate regular workshops or webinars as community engagement events to socialize Labs and social innovation approaches
- Localize Accelerator Lab innovation methodologies. Translate Accelerator Lab communication materials and create contents on social innovation that's relevant to Viet Nam (writing blog, copy-editing etc...). Working together with Labbies and AccLab to design and promote outreach materials.
- Social media and marketing, to continuously promote Labbies Network program and activities. Write contents for social media, design posters, etc

#### F. Institutional Arrangement

The coordinator team main point of contact will be **Head of Solution Mapping** and will report to all Heads of **Accelerator Lab** team in Viet Nam.
