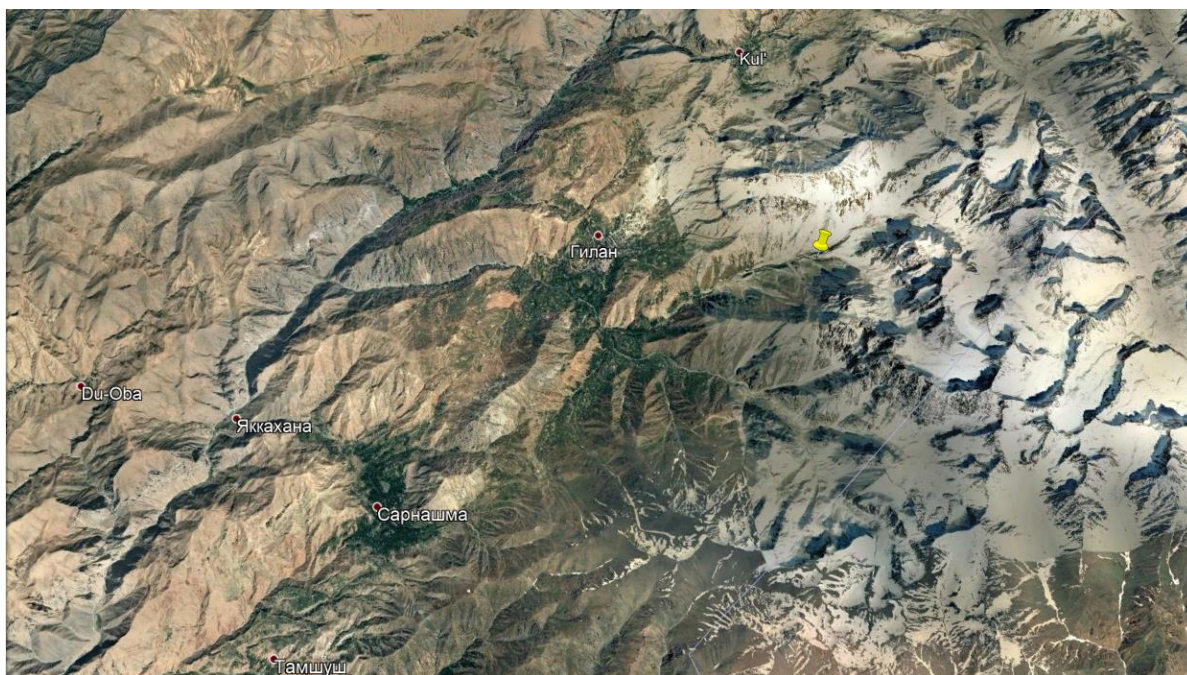

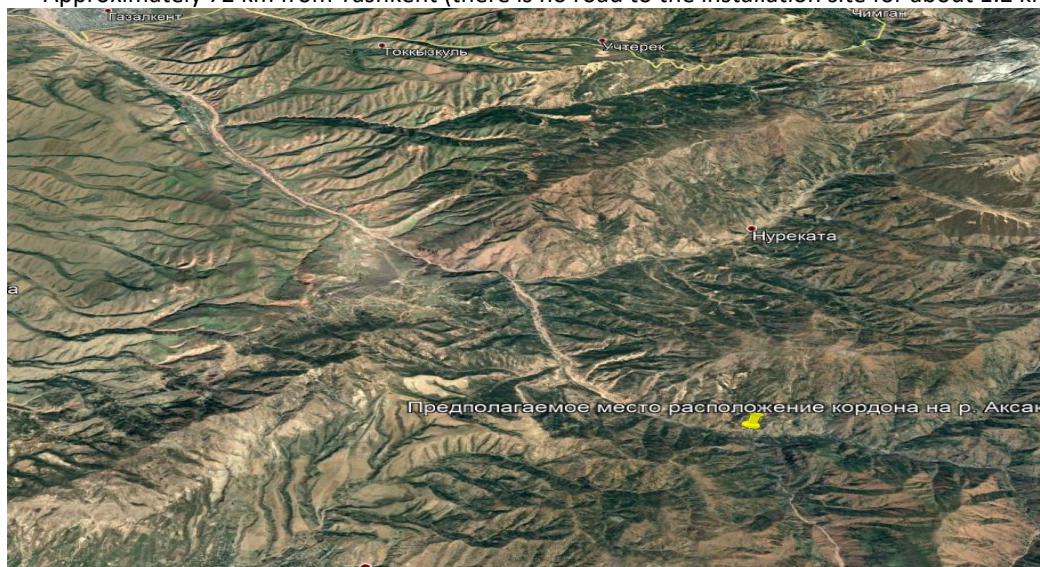


**Installation diagram of solar panels for generating 5 kW electrical energy in Ugam-Chatkal State National Natural Park**



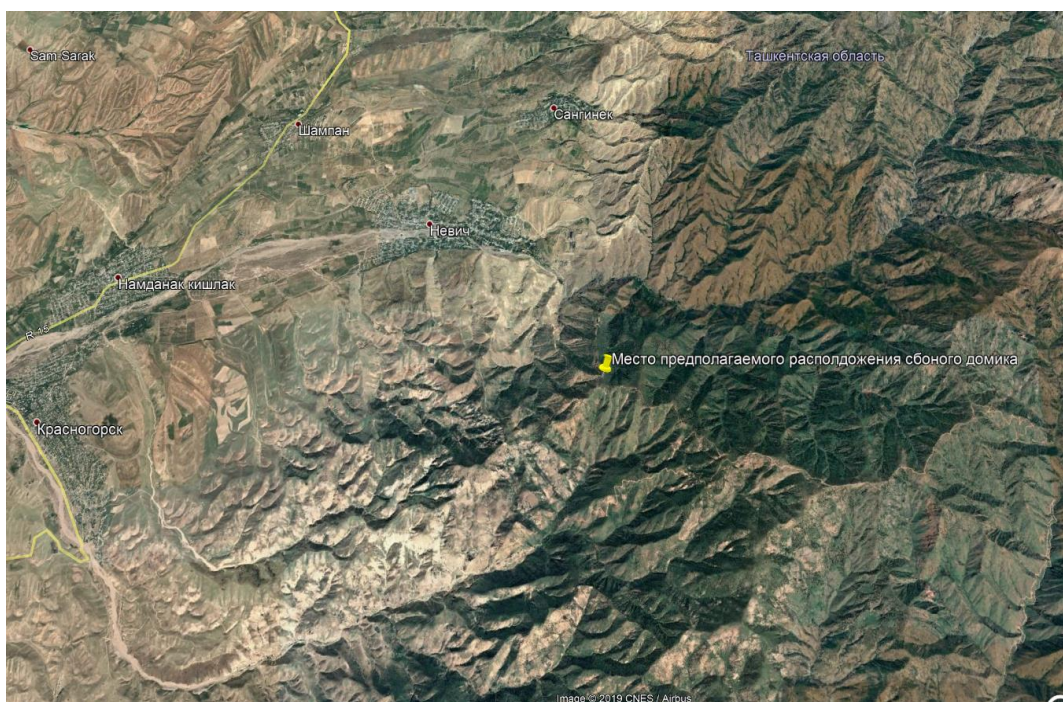
