# 1) GENERAL BACKGROUND

During the first half of 2020, the novel coronavirus (COVID-19) pandemic has spread rapidly throughout the world. COVID-19 is causing unprecedented human, social and economic disruption, leaving no community or nation untouched. By early August 2020, COVID-19 had spread to well over 200 countries, with the number of confirmed cases surpassing 19 million and the death toll exceeding 700,000. Global disease epicenters continue to shift, and the worldwide number of cases recorded per day was still rising.

The Government of Viet Nam's rapid response achieved outstanding results in disease prevention and control despite a shared border with China, the original epicenter of the virus. Viet Nam did not record its first death from COVID-19 until early August 2020, at which time the total number of cases was just 600. Regular international flights are yet to resume, and strict border controls remain in place.

The COVID-19 pandemic presents an unusual constellation of economic problems in that it is simultaneously a supply and demand shock. The supply shock originates in the disruption to supply chains of domestic producers, whether from overseas or within Viet Nam, due to the impact of the disease and prevention and control measures. The demand shock stems from the reduced purchase of goods and services contributing to interruptions to international and domestic production and trade in goods and services resulting in reduced earnings, lost income and depressed consumption levels.

In Vietnam, businesses are facing many difficulties and challenges, and the country's socioeconomic development goals have been affected. According to the General Statistics Office (GSO),<sup>3</sup> GDP increased by 3.8 percent in Q1 2020, compared to 6.8 percent in Q1 2019. In Q1 2020, the Agriculture sector contracted by -1.2 percent and industry grew by 5.3 percent, much lower than the 10.5 percent growth in Q1 2018 and 9.0 percent growth in Q1 2019. Growth of 3.3 percent in the service sector was the lowest since 2011. In May 2020, the Government proposed to reduce the annual GDP growth target from 6.8 percent to 4.5 percent. This would be Viet Nam's lowest annual growth rate since 1999, and before that since the 1980s.

At the same time, Viet Nam's timely and effective response ensured that, while many other countries in the region are still struggling to bring COVID-19 under control, the country can start

to focus on the forward-looking recovery process. Viet Nam is expected to be the fastest growing economy in the ASEAN, and to be one of the very few to have a positive growth outlook for  $2020-21.^4$ 

While private sector, particularly MSMEs, were significantly affected during the pandemic, the country adopted a number of measures to ensure that production and service delivery could take place to the extent possible, given reliance on imports for a raw materials and components in a number of industries and the disruption of global supply chains.<sup>5</sup> Moreover, there are emerging opportunities that can be capitalized upon, including from investors looking to diversify sources of supply and opportunities to develop domestic substitutes for imported components and finished products. The next period of national growth requires an anticipatory, agile and adaptive response from Government, local bodies, industries and enterprises to minimize risks and capitalize on new opportunities arising from changes in global supply chains and trade patterns.

The Government has already taken several measures in this regard. On May 29, 2020, the Government issued Resolution No. 84 / NQ-CP on tasks and solutions to continue eradicating difficulties for production and business, promoting disbursement of public investment and ensuring social order and safety in the context of the COVID-19 pandemic. The Resolution assigns the Ministry of Planning and Investment (MPI) as the lead agency to synthesize and report to the Prime Minister on the difficulties and recommendations of the business community; formulating projects to support industrial development, and anticipating and realizing opportunities from changing investment patterns after the COVID-19 pandemic. In May 2020, MPI proposed the establishment of a Special Task Force on Attracting FDI in order to 'catch the wave of FDI' following COVID-19. In particular, it is important to attract high-quality FDI for the development of Vietnamese industry. In 2018, Vietnam attracted \$36.4 billion in FDI commitments, of which \$19 billion was disbursed.

It should be noted that the focus is not just on increasing FDI and competitiveness in the post-COVID-19 period, but building on the progress over the past few decades to shift the focus in the next phase to high-quality FDI combined with domestic private sector development to ensure greater resilience and diversification going forward.<sup>6</sup> With respect to FDI, the focus is on creating incentives to achieve better linkages between foreign and domestic firms, including of SMEs.<sup>7</sup>

Even with a context overshadowed by COVID-19, the Government's industrial policy will continue to emphasize sustainability and inclusiveness. As a nation with a long coast and densely populated river deltas, Viet Nam is vulnerable to climate change. Sea-level rise and flooding place millions of residents at risk of displacement and also threated agricultural and industrial production.<sup>8</sup>Reducing the negative impact of industrialization on the environment has emerged as an important goal as water and air pollution levels have risen. Increasing energy efficiency, developing renewable energy sources and improving solid waste management are key objectives.

Viet Nam's National Green Growth Strategy (2013) includes a focus on promoting clean industrialization through resource efficiency and advanced technologies. Importantly, there is growing interest in sustainability in global value chains and opportunities for Viet Nam to leverage niche markets. COVID-19 has accelerated the use of new information technologies and there is scope to support MSMEs in strengthening their capacity to adopt information-intensive production methods associated with the Fourth Industrial Revolution.

The Government has assigned a high priority to connecting FDI and domestic private investors with SMEs to accelerate industrial development and increase domestic value added. SMEs are a key sector of the Vietnamese economy (40 percent) and a significant contributor to employment, poverty reduction and sustainable development. Closer and more sustainable integration of SMEs into global and domestic supply/value chains, including the creation of a vibrant start-up ecosystem, is central to the Government's approach to industrial policy.<sup>9</sup>

Studies relating to the supply chains of highly impacted and potential growth industries/sub sectors in the context of post COVID-19 are useful to identify opportunities and challenges for Vietnamese businesses during the pandemic and in the recovery period. UNDP will assist the Government in this research with support for studies of three sectors in which SMEs are already active and could increase participation with the implementation of appropriate policies.

The research will consist of qualitative and quantitative analysis of sector supply chains leading to recommendations to the Government to assist in national industrial policy formation for COVID-19 response and recovery of the private sector. In view of the expressed intent of objectives of global companies to manage supply chain risks, the studies will help Viet Nam emerge as preferred destination for investors planning for the post-COVID period.

This ToR is for a Vietnam based firm to conduct research on COVID-19 impact and supply chain analysis including various methods of analysis including interviews with relevant stakeholders in enterprises in each sector.

# 2) OBJECTIVES OF THE ASSIGNMENT

The main objective of the assignment is to provide technical inputs to help the Government of Viet Nam to assess the impact of COVID-19 on Viet Nam's supply chains and to identify opportunities and constraints in developing a plan to support a sustainable COVID-19 response and recovery of the private sector in Viet Nam.

Specifically, the research will consist of:

- A strategic, high-level Viet Nam sectoral supply chain review in the context of COVID-19 pandemic;
- A rapid **mapping of emerging opportunities within three sectoral priority areas**<sup>10</sup> to focus attention on re-engineering and overhauling supply chains and strengthening the policy and institutional ecosystem in Viet Nam;
- Proposals for intervention by Government, industries/sectors and enterprises (including but not limited to State-Owned Enterprise (SOEs), Large Domestic Enterprises, Small and Medium Enterprises (SMEs) and Foreign Direct Investment enterprises) including

changes to tax policy, financing and catalytic investments in key areas, and skill development to promote the improvement the efficiency/competitiveness, value-added and sustainability of the supply chains in three selected areas, and;

• Proposals to promote the integration of SMEs into global and domestic supply chains through supplier development and measures to improve the ecosystem for SMEs and start-ups/accelerators, including by youth in the digital space.

# **3) SCOPE OF WORK**

The consultant team will complete the following key tasks:

# I. Undertake a strategic, high-level sectoral supply chains review in the context of COVID-19 pandemic (10 percent)

- Outline the impact of COVID-19 on economic development, particularly for strategic focus areas in the economy, and the interventions deployed by the Government of Viet Nam and private sector;
- Identify risks and opportunities for Viet Nam emerging from the changed international economic and financing landscape in the wake of the COVID-19 pandemic
- Based on the analysis, recommend focus areas for sectoral supply chains, which are potentially "high impact" or offer opportunities post-COVID 19 and are important to the five-year socio-economic development plan; identify three sectors or sub-sectors for in-depth study based on an objective assessment of the potential within these sectors or subsectors to increase the role of domestic firm especially MSMEs in supply chains, and to create formal sector employment.
- The selected sectors will be finalized and agreed during the first phase of the assignment based on an assessment of the potential of each sector to increase linkages with domestic firms, especially MSMEs, and to create steady employment based on the principle of "No one will be left behind". Some sectors and subsectors that that might be considered include: 1) Transportation; 2) Manufacturing: Garments, Footwear; 3) Electronics Manufacturing; 4) Agriculture, including horticulture and floriculture; 5) Tourism; 6) Infrastructure & Construction; 7) Energy: Renewable energy (solar, wind), LNG; 8) Environment & Water treatment (waste and supply); 9) Retail; 10) IT. Diverse sectors or subsectors with a wide range of entry points (for example, garments and agriculture) are more likely to meet these criteria than highly concentrated, capital and technology-intensive and specialized sectors.<sup>11</sup>
- Describe the methodology used for the selection of the three sectors or subsectors for further analysis and present the results of the analysis to explain the rationale for selected these sectors or sub-sectors;
- Present an overview of the entire value chain, including international trade, financial market dimensions, while capturing: (i) key and supporting activities in the supply chain; (ii) the linkage between activities in the chain and break-points; (iii) activities that create the highest value in the chain and strategic opportunities for domestic firms to increase local content, resilience and/or avoid disruption while also moving to meet

sustainability criteria; (iv) key actors and their role in the supply chains; (v) potential risks, challenges and opportunities;

• Desk research and review on impact of COVID-19 on each sectoral supply chain, and the interventions deployed by the Government, industrial sectors and enterprises; analyse the deployed interventions by at least 3 other countries' governments as the impact of COVID-19 pandemic and propose the lessons learnt for Viet Nam;

# [Methodology]

- Leveraging the critical insights gathered through General Statistics Office, MPI data and sources from various industrial associations, international organizations, etc;
- Benchmarking studies on sector-specific international best practices from global resource;
- Supply chain model analysis;
- Peer review by external senior experts.
- Desk research and reviews
- II. Develop an action plan for three sectors selected as described above based on the potential for increased domestic value added and employment generation out of the 10 key sectors that significantly contribute to COVID-19 economic recovery and response of Viet Nam including in-depth analysis to identify new opportunities and possible Government support (90 percent).
  - Examine the impact of COVID-19 on the three sectors or sub-sectors identified as described above, including the impact of Government policies and response of businesses in the public and private sectors;
    - Review to the extent possible production, employment, inventories of inputs and finished product in the sector during the pandemic period

    - Outline the characteristics of foreign firms which could potentially bring in the desired technologies and promote skilling & management spillovers, particularly in areas with a forward-looking niche focus on promoting competitiveness with sustainability;
    - Point to promising emerging trends and practices in these sectors and outline the characteristics of domestic firms (both state-owned and private sector including MSMEs) with a view to assessing the issues affecting the absorptive capacity and/or maximize spillovers, and where supplier development, accelerator and/or other programs would be catalytic.
  - Generate policy recommendations to increase the participation of national firms, especially SMEs, in the supply chains of the three selected sectors or sub-sectors, and draft a framework for the evaluation of these policies over an 3 year period

which includes 1) short-term action for 6 months; 2) mid-term action for 1 year; 3) long-term action for 3 years;

- Identify government support measures to promote FDI and investment by domestic financial institutions in the 3 selected priority sectors or sub-sectors and/or cross cutting ecosystem supportive areas including incentive systems such as credit policy, taxation, training; and risk-sharing for investment in new sustainable technologies, packaging and logistics, technologies and partnerships with domestic forward-looking start-ups.
- Make recommendations to use high quality FDI as a vehicle: (1) for obtaining foreign technology, knowledge, managerial skills, and other important inputs;
   (2) for integrating into international marketing, distribution and production networks; (3) and for improving the international competitiveness of firms and the country's economic performance.

- Review of existing sectoral studies and comparison with other middle-income countries, especially from the Asia-Pacific region;
- Primary data collection from a sample of firms in each sector, including in-depth interviews with purchasing managers and SME owners to assess risks and opportunities for domestic firms, especially SMES, and to assess the impact of Covid-19 and policies in response to COVID-19;
- In-depth case studies of domestic firms that have achieved integration with domestic and international supply chains in these sectors, including lessons learned;
- Development of an evaluation framework to assess these policies over and 18-month period, and detailed methodology and terms of reference for these evaluations.
- Development of an evaluation framework to assess competitiveness of firms and the country's economic performance.
- Use of machine learning, data mining, Meta-analysis or economic modelling (It can be changed depending on the state of the data set);
- Peer review by external senior experts;
- Support to organise minimum 1 half-day workshop in Hanoi to get comments from relevant stakeholders and to present the research findings (ministries, government agencies, associations, industry experts, and so on). The cost for the workshop will be covered by UNDP.

\* The research methodology for this study is not limited to the methodology presented above.
