LOT No. 1. SUPPLY AND INSTALLATION OF 4 SETS OF REFRIGERATING EQUIPMENT FOR 4 COLD ROOMS WITH THE CAPACITY OF 75 TONS EACH

DESCRIPTION:

Supply and installation of 4 set of refrigerating equipment in full for 4 cold rooms with a capacity of 75 tons each. A set of refrigerating equipment should consist of a unit based on a Bitzer 4PES-15-40P compressor (or equivalent), an air cooler, an electronic control unit, a complete package of fittings, expansion valves, valves, seals and copper tubes that combine the hardware and cooler, and must also have the necessary electric wires and refrigerant R404 or other ozone friendly refrigerant in sufficient quantity for the full operation of the system.

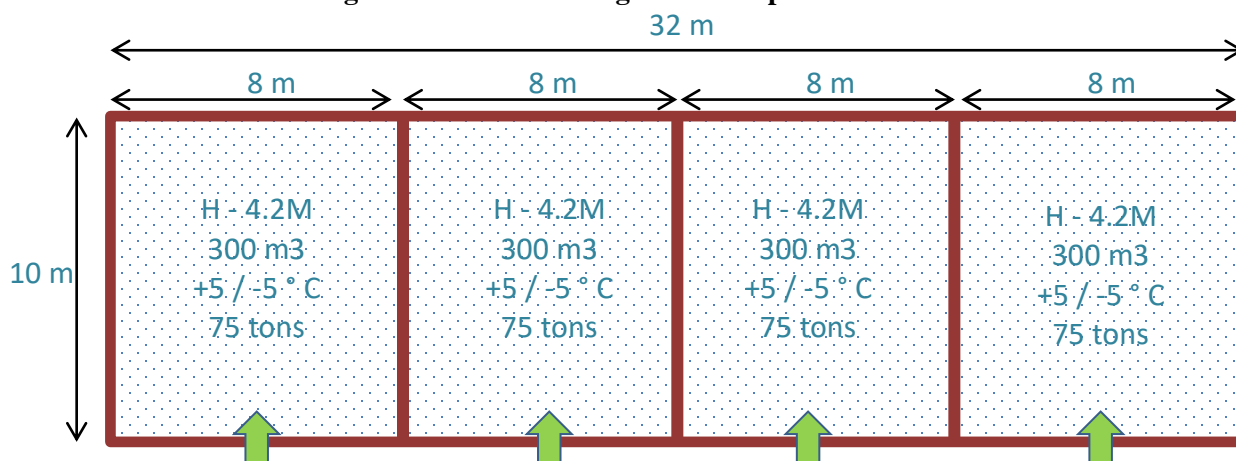

Dimensions of cold rooms: 10m long; width 8m; height inside the cold room 4.2m (4 cold rooms). Volume of each cold room: 300 m3. Construction of cold rooms will be carried out by the end user and will be completed by the date of delivery of cooling (refrigeration) equipment.

A set of refrigerating equipment should consist of a unit based on a Bitzer 4NES-20-40P compressor (or equivalent), an air cooler, an electronic control unit, a complete package of fittings, expansion valves, gaskets and copper tubes that combine the hardware and cooler, and should also have the necessary electric wires and refrigerant R404 or other ozone friendly refrigerant in sufficient quantity for the full operation of the system.

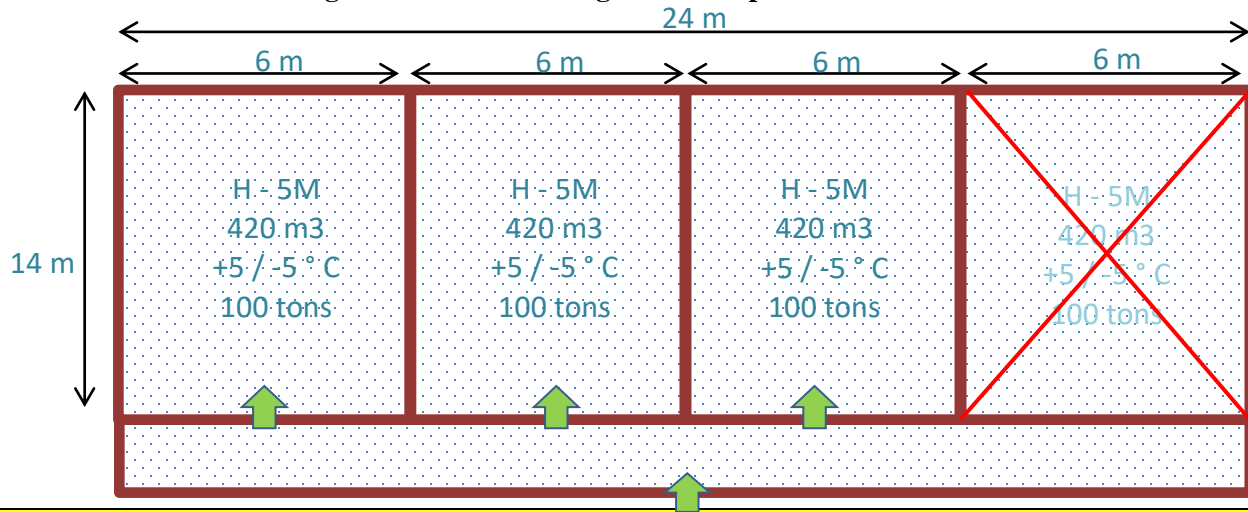

Overall dimensions of the complex: length 14m; width 24m, indoor height 4.2m

Sizes of cold rooms: length is 14 m; width 6m; height inside the cold roomr is 5 m (equipment only for 3 cold rooms is required). Volume of each cold room: 420 m3. Volume of each cold room: 300 m3. Construction of cold rooms will be carried out by the end user and will be completed by the date of delivery of cooling (refrigeration) equipment.
