A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared.

The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component. The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR). Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. $S_f = 1000 \times F_m / F$, in which S_f is the financial score, F_m is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected subject to positive reference checks on the consultant's past performance.

Interview with the candidates may be held if deemed necessary.

1. BACKGROUND

The EU Justice and Legal Empowerment Programme (EU JULE), implemented by UNDP and UNICEF together with relevant State agencies, is designed to strengthen the rule of law through a more reliable, trusted and better accessed justice system, and specifically to increase access to justice for women, children and those groups which face the greatest obstacles in using the justice system to invoke their rights, including ethnic minorities and poor people.

The objectives of the programme are to be achieved through a number of interventions, including increased public awareness and understanding of rights and how to invoke those rights according to principles enshrined in Vietnamese law, mechanisms and procedures for how to use the law, and options for seeking legal advice, assistance and representation.

Under the EU JULE, one of the key areas of intervention is to support implementation of the Law on Legal Aid and the Legal Aid Reform Project for the period 2015 - 2025.

The legal aid system in Viet Nam was established by Decision No. 734/TTg dated September 6, 1997 of the Prime Minister. According to this Decision, the system of the State legal aid providing organizations includes the National Legal Aid Agency (NLAA) under the Ministry of

Justice (MOJ) and State legal aid centers under the local Departments of Justice in the provinces. The first Legal Aid Law was promulgated in 2006. After 10 years of implementation, the 2006 Legal Aid Law exposed many gaps and was replaced by the 2017 Legal Aid Law, which came into effect on 1st January 2018.

In accordance with Law on Legal Aid in 2017, legal aid-providing organizations include state legal aid centers and organizations participating in legal aid provision (organizations signing legal aid contracts and organizations registering to participate in legal aid provision). Now, there are 63 state legal aid centers in 63 provinces and centrally running cities, 33 organizations signing a legal aid contract with provincial-level Justice Departments (24 law-practicing organizations and 9 legal counseling organizations), 161 organizations registering to participate in legal aid (128 law-practicing organizations and 33 legal counseling organizations). According to local statistics, at the end of December 31, 2019, the nationwide had 643 legal aid officers, 571 lawyers signed legal aid contracts with the Center and 32 collaborators. At the same time, the 2017 Law on Legal Aid expanded the scope of legal aid beneficiaries from 6 groups to 14 groups, so the number of legal aid beneficiaries was increased.

In 2019, under the EU JULE Programme, UNDP has supported the National Legal Aid Agency, Ministry of Justice to conduct a capacity need assessment for legal aid providers. The assessment showed the need for strengthening capacity and skills for legal aid providers, especially for providing legal aid in the marriage, family and land cases.

In this context, this year, under the EU JULE, UNDP continues providing support to the National Legal Aid Agency, Ministry of Justice to develop two guidelines for legal aid providers on how to provide legal aid in marriage, family and land cases.

2. OBJECTIVES OF THE ASSIGNMENT

To develop two guidelines for legal aid providers on how to provide legal aid in marriage, family and land cases.

3. SCOPE OF WORK

The activity will be carried out by two national legal consultants and one international legal consultant hired by UNDP in consultation with the NLAA.

The three legal consultants will work together in a team. The scope of work for this assignment is as follows:

a. National legal consultant – team leader (22 days)

Leadership (2 days):

- The team leader is ultimately responsible for the final products;
- Take the lead in discussion with other consultant, UNDP and NLAA on performing the assignment
- He/she is responsible for the entire process of performing the assignment and ensuring quality of the products that will be submitted to UNDP and NLAA

Developing guidelines (20 days)

- Coordinate with other consultants to develop and submit to UNDP and NLAA workplan for implementing the assignment with clear timelines (1 day)
- Prepare outlines of the two guidelines and share with other consultant, UNDP and NLAA to receive inputs and revise the outline accordingly (2 day);
- Liaison with the NLAA to identify at least 10 legal aid providers, who have more than 10 years working experience in providing legal aid on marriage, family and/or land cases (1 day);
- Based on the questionnaires prepared by other national legal consultant, conduct interviews through phone with the identified legal aid providers to collect information on skills and experience on providing legal aid on marriage, family and land cases with typical case studies (2 days)
- Based on the approved outlines and the information collected from legal aid providers and the materials provided by other consultants, draft two guidelines (6 days);
- Share the draft two guidelines with other consultants, UNDP and NLAA to get comments and revise the draft guidelines accordingly (3 days);
- Prepare and deliver presentation on the draft guidelines at a one-day consultation workshop in Hanoi (2 days);
- Revise and finalize the draft guidelines based on the comments received from the workshop and submit to UNDP and NLAA for approval (3 days).

b. National legal consultant - team member (17 days)

- Collect and analyze current Vietnamese legal documents relating legal aid for marriage, family and land cases, as well as relevant existing studies and guidelines (4 days);
- Prepare questionnaire for interviewing legal aid providers on skills and experience on providing legal aid on marriage, family and land cases with typical case studies (1 day);
- Assist team leader in interviewing legal aid providers to collect and analyze information and typical case studies to illustrate the points provided in the guideline (2 days);
- Provide inputs to the draft outlines of the two guidelines prepared by the team leader (1 day);
- Assist the team leader in drafting the guidelines, especially the sections on legal framework and case studies (5 days);
- Attend a one-day consultation workshop in Hanoi to assist the team leader in collecting comments from participants for the draft guidelines (1 day);
- Assist the team leader in revising and finalizing the guidelines (3 days).

c. International legal consultant – team member (8 days)

- Collect and analyze international instruments relating legal aid provision and relevant guidelines of foreign countries on how to provide legal aid in marriage, family and land cases to provide good guideline examples for national consultants to develop guidelines for Viet Nam (3 days);

- Provide inputs to the draft outlines of two guidelines prepared by national consultants (1 day);

4. FINAL PRODUCT

The three consultants will produce:

Two guidelines for legal aid providers in Vietnamese and English: (1) First guideline on how to provide legal aid in marriage and family cases; and (2) 2nd guideline on how to provide legal aid in land cases. These guidelines should align with the international standards and Vietnamese legal aid practices (5,000 words max, equivalent of about 15 pages per guideline). These guidelines can focus on, but not limit to:

- Legal framework relating marriage, family and land issues
- International standards relating legal aid provision
- Skills for legal aid providers on how to provide legal aid in marriage, family and land cases illustrated by typical case studies

The product can be seen as final when it gets approval from UNDP and NLAA and is uploaded by NLAA in the website of the Ministry of Justice for distributing to legal aid providers.
