

The project includes the following: A: Works of Temporary Alternative Road, Diverting The Existing Irrigation Canal

#### Path Temporarily and Signs:

The work includes; making a temporary alternative road, removing 20 cm of the alternative ground of road path with clearing from grass and weeds to at least a depth of 30 cm leveling and compacting all the project area, removing all debris from the site to a dumpsite approved by the relevant authority, spreading six layers of clay, the side slop is 1:1.5, the quantity filling of 3m width used to hold the water of the existing irrigation canal from two directions to change the water bath to the alternative irrigation canal and above the pipes of the new alternative irrigation canal, spreading and compacting two sub-base layers type B, all works at site should be according to general specification for Roads & Bridges (SORB) and the direction of supervisory engineering committee, removing the alternative road after completing the construction works with leveling the ground and removing all debris from the site to a dump site approved by the relevant authority. The contractor must maintain the alternative road throughout the period of implementation of the project, all needed work to complete the job will be included within the price.

Excavation of the temporary alternative irrigation canal path to divert the existing irrigation canal path away from the bridge area as mentioned in detailed drawings, supplying and installing 3 iron pipe lines of 1m diameter, 12mm thick for ensuring water flow in bed of divert irrigation canal with length 18 m for each pipe according to direction of supervisory engineering committee (The contractor has the right to dispose of these pipes after completing the project implementation), backfilling the divert irrigation canal to resume normal irrigation canal stream after finishing the construction works using the resulting material from the canal excavating and 50 cm thick sub-base layers for the upper layers with well compaction.

#### **B: Excavation and Backfilling Works for Bridge Parts**

The work includes; excavation works with compacting the natural ground, spreading and paving stone not more than 40cm layer class C with compaction, spreading layers of clay for the excavated area between the approach slabs and abutments with compaction, spreading sub-base layers class B under foundation, under and above approach slab and the areas under the damaged bed and banks of irrigation canal under the bridge up to the required design level.

#### **C: Concrete Works**

Concrete works include; casting plain concrete for under foundation, under approach slab, and for the gutter, casting reinforced concrete with formwork for the foundations, abutment retaining walls, abutment wings, approach slab, deck slab, diaphragm beam and sidewalk. **D: Bearing Pads and Expansion Joint Seals Works** 

The work includes; supplying and installing reinforced high compacted elastomeric bearings of  $(300 \times 200 \times 74)$  mm dimensions, the type of rubber should be (Chloroprene), casting reinforced concrete grout pads of (L:400 x W: 400 x T: Variable not more than 200) mm dimensions using master flow cement, special Epoxy materials for the bond between bearing and concrete and all required accessories.

Supplying and installing waterproof expansion joint seals (chloroprene), type T100 which should be installed in both abutments within the carriageway, using specified bolts for

supporting, angle steel section of 2 inch and 4 mm thick in concrete edges which should be connected with steel bars during concrete casting, painting with anti-rust primer paint and oil based paint, using support joints between concrete sides during casting and removing it after 48 hr. according to the attached detailed drawing and general specification specified for Roads and Bridges and the instruction of supervisory engineering committee, using of special filler materials to bond & leveling the expansion with asphalt & deck slab respectively. **E: Precast Concrete Girders Works** 

The work includes; casting and installing reinforced concrete pre-stressed pretension girders (I section) type, 13 m length and 85 cm depth, using high yield strength of (460 N/mm2) (Grade 60) deformed steel reinforcement and steel strand wire according to the general specification specified for Roads and Bridges, designs, lengths, dimensions mentioned in attached drawings. The Contractor must verify survey works and dimensions of the spans before casting concrete girders.

#### F: Pavement, Sidewalks and Road Marking Works

The work includes; spreading the road above approach slab with one asphalt layer - base layer (stabilizer) of 10 cm thick after compaction, spraying binder liquid (Prime coat) for a period not less than 24 hr. before the paving according to the technical specifications of the roads and bridges, the contractor shall submit a new design equation of the asphalt mix for the project as per Iraqi specifications in order to get approval by the end-user and supervisory engineering committee before starting the work. All the works should be complied with Iraqi specifications No. (SORB/ R8 & R9) and directions of the engineering supervisory committee.

Finishing with asphalt surface layer of 6 cm thick after compaction as per Iraqi general specifications for bridge, the work includes spraying binder liquid (Tack coat) under the asphalt layer for a period not less than 18 hr. before the paving according to the technical specifications of the roads and bridges, the contractor shall submit a new design equation of the asphalt mix for the project as per Iraqi specifications in order to get approval by the end-user and supervisory engineering committee before starting the work. All the works should be complied with Iraqi specifications No. (SORB/ R8 & R9) and directions of the engineering supervisory committee.

Manufacturing and installing galvanized steel bridge hand railings with all accessories according to the details and design of hand railings mentioned in the attached drawings. Casting and install fascia concrete panels of (L: 85 x W: 80 x H: 65) cm dimension as per attached drawings. All the works should be complied with the general specification specified for Roads and Bridges and directions of the engineering supervisory committee.

Installing concrete curbstone made by machine (manufactured using the mechanical method) which should be installed in the bridge sidewalk according to the required specification and with all required works.

Marking the bridge with continuous parallel road marking lines of 20 cm width and yellow color using reflected powder (500 gm/m2) (thermoplastic painting for road marking) and the thickness of the coating layer not less than 2.5 mm.

Installing the cast iron gullies for the rainwater drain with all required work.
