Please be informed that **changes** are made on the technical specifications of the items to be procured for the above subject.

<ul style="list-style-type: none"> <li>• All food items must be branded, Halal-certified and approved by the Food and Drug Administration (FDA), and must have a shelf-life of at least 6 months, except for biscuits with a 4-month minimum shelf-life.</li> <li>• Alcohol, soap, toothpaste and sanitary napkins must be branded and registered with Department of Trade or patented.</li> <li>• For weight and volume, a variance of 10 grams or 10 ML is accepted.</li> <li>• Packaging for each of the items must be sealed and secure, without any leaks, cracks, holes, or any form of damage or tampering.</li> </ul>	<ul style="list-style-type: none"> <li>• Delivery within 3 weeks after issuance of Purchase Order</li> <li>• <b><i>All food items must have Food and Drug Administration (FDA) registration and Halal certification.</i></b></li> <li>• <b><i>All food items must be properly labelled with best before and expiry dates legibly printed on the packaging. Must have a remaining shelf life of at least 6 months at the time of delivery except for biscuits which is at least 4 months.</i></b></li> <li>• <b><i>Packaging must be in good condition, properly sealed and secured, free from dust and dirt, without any leaks, dents, cracks, holes, or any form of damage or tampering. Canned products must not have bulging or swelling ends.</i></b></li> <li>• <b><i>Alcohol, soap and toothpaste must be branded and registered with the Food and Drug Administration (FDA)</i></b></li> <li>• <b><i>Sanitary napkins must be registered with Department of Trade (DTI) or patented</i></b></li> </ul>
