Reference is made to the above-mentioned subject, we have noticed that in the bid documents- section- 3 - Bid Date Sheet & Summary Price Sheet (page 43) , the sub-projects that related to **Lot 2** are mentioned as follow:

- 1 / Construction Of Police Post Office, Location – Jabelmoon / Mestraheha Or Goze Menno
- 2/ Construction of Rural Court/District Court, Location – Jabelmoon / Silea
- 3/ Construction of Prosecution Office, Location – Jabelmoon / Silea
