With reference to the above Invitation To Bid (ITB) dated 19 October 2020, please find the following clarification questions and responses. The deadline for submission has been extended to 16 November 2020.

Questions and Answers

Sr. No.	Question	Answer
1	Your delivery points as mentioned in the ITB are 4 separate locations in Rakhine State. As you may know, some of the locations in Rakhine are unstable, and we would like to know what you plan if there is a delivery issue because of this.	UNDP support recommendation letter from DOA to get the Rakhine state government approval. Bidder is responsible any other risk including selecting safer mood of transportation to deliver the distribution of Distribution Points as per ITB.
2	In your technical specifications document, listed in 4.4 is, "The cost of undertaking pre-delivery and final inspection and basic training must be included in the bid price". Could you please let us know what is meant by "basic training"?	Basic Training refer: the basic operational training to agri-land committee or township DOA staff (at delivery location, DOA offices) on how to install/set up the power tillers and how to run it based on the manual guides.
3	Depending the description of the product, we are sure that what you need is below, but for below product the "Rated Output (HP): Minimum 18-Maximum 22" is not right, the maximum is 8HP. "Engine weight (Kg): more than 170" this is not possible. Please confirm the specifications again or provide a picture for reference so that we can submit.	The below pictures are sample photos of 22HP hand tractor, and the specification are as per ITB

4	In case of war or other force majeure, can the delivery date be extended or delivered elsewhere?	Please see below for detail refer to GCC. 9. FORCE MAJEURE; OTHER CHANGES IN CONDITIONS: 19.3 Force majeure as used herein means any unforeseeable and irresistible act of nature, any act of war (whether declared or not), invasion, revolution, insurrection, terrorism, or any other acts of a similar nature or force, provided that such acts arise from causes beyond the control and without the fault or negligence of the Contractor. The Contractor acknowledges and agrees that, with respect to any obligations under the Contract that the Contractor must perform in areas in which UNDP is engaged in, preparing to engage in, or disengaging from any peacekeeping, humanitarian or similar operations, any delays or failure to perform such obligations arising from or relating to harsh conditions within such areas, or to any incidents of civil unrest occurring in such areas, shall not, in and of itself, constitute force majeure under the Contract.

6	Shall a soft copy of the bid security be uploaded in E-Tendering System?	Yes
