## I. BACKGROUND

"UNDP partners with people at all levels of society to help build nations that can withstand crisis, and drive and sustain the kind of growth that improves the quality of life for everyone. On the ground in 177 countries and territories, UNDP offers global perspective and local insight to help empower lives and build resilient nations." UNDP Indonesia's mission is to be an agent for change in the human and social development of Indonesia. We aim to be a bridge between Indonesia and all donors as well as a trusted partner to all stakeholders. We work in four key areas of development: Governance Reforms, Pro-Poor Policy Reforms, Conflict Prevention and Recovery, and Environment Management, with the overarching aim of reducing poverty in Indonesia. Besides the four priority areas, UNDP Indonesia is also engaged in a variety of crosscutting initiatives focused on HIV/AIDS, gender equality, and information and technology for development."

In early 2020, the COVID-19 outbreak hit the global community and has been disrupting economic, social and environmental aspect of development, among others. People with low-income, people working in informal sectors, people with disabilities, and women-headed households are vulnerable groups that has been severely affected by the pandemic. These vulnerable people are in critical need to be supported, and a substantial number of them lives in villages across Indonesia.

On similar note, the outbreak has also been hurting Gol's efforts towards achieving SDGs by 2030. Setbacks in poverty reduction, economic growth, and environmental protection are likely; which will also be exacerbated by the reduction in budget allocation to such sectors given the budget prioritized for COVID-19 response.

Against that background, UNDP Indonesia and Ministry of Village partner to accelerate SDG achievement in >70,000 villages. The cooperation is in line with UNDP's mission to ensure that *no one in the villages is left behind*. Among the cooperation is the application of app-based *Padat Karya Tunai Desa (PKTD)/*Cash for Work (CfW) in response to social economic impact of COVID-19 and its Monitoring and Evaluation application, application of Social Innovation Platform for the acceleration of socio-economic development in rural areas, and alignment of MoV measurement frameworks with SDGs.

UNDP Indonesia together with Ministry of Village (MoV/Kemendesa PDTT) initiated to provide safety net for villagers. Partnered with Microsoft as developer of the app-based PKTD/CfW. The tech system is considered safer in order to get the work done, most out of it without any physical contact as to prevent the spread of COVID 19. It is implemented to reduce socio-economic impact to vulnerable households caused by the COVID-19 pandemic, and to stabilize livelihood and maintain social cohesion in the target villages, also to provide an innovative and integrated Monitoring and Evaluation method of CfW. The CfW will be innovative through the use of mobile app for the database, and its implementation and monitoring of the activity and will be integrated to MoV's existing MnE platform. The other innovation is digital cashless payment for workers.

Participation of vulnerable groups, including persons with disability in the Cash for Work Activities will be crucial, ensuring *No One Left Behind* (NOLB) towards citizen's engagement during crisis situation. CfW application also will ensure the observation of COVID-19 safety protocols.

The Cash for Work App Development consultant will work with various stakeholders to ensure quality of the application, such as ensuring the application is in line with COVID-19 protocol provided by UN Agencies and GoI, ensuring that stakeholders are well-informed and approved the application and its operations, and ensure that application is suitable and applicable with the pilot area.

The consultant will work with the chosen app developer, UNDP, Ministry of Village, local provincial government, local district government, village officials, and village facilitators to ensure the high-quality practice of Cash for Work in pilot area.

Under direct supervision of the Head of ICT Unit and overall guidance from both ACHIEVE and RESTORE projects, the Cash for Work App Developer Consultant will be supporting UNDP to ensure abovementioned requirements.

## Scope of Work

The consultant will:

- Acting as UNDP's focal point for liaising with selected CfW app developer (Microsoft Team), government partners, and other stakeholders.
- Designing an integrated database between the CfW application and database of the MoV.
- Ensure the quality of CfW application by working with selected CfW app developer, and consulting with supervisor.
- Provide assistance to make sure the applicability of the mobile application in pilot area, including the training of village facilitator in the pilot area.
- Provide assistance to integrate the CfW mobile application with MoV's monitoring and evaluation dashboard, and MoV's database.
- Provide assistance to related stakeholders as required.
- Perform other tasks as required by supervisor.
