Answer 1: It is not possible to provide the Bid Security in a format other than the one provided in the ITB document, i.e in Turkish. As per Clause 6 in Section 3 — Bid Data Sheet of the ITB, acceptable form of Bid Security is Bank Guarantee template given in Section 6, Form G, and also given in the attachment for ease of reference. No change shall be made to the template given in FORM G except for the indicated fields. Any change or deviation from the template will constitute grounds for rejection.
