Specification

Project name: The UN Program on Socio-Economic Recovery of Kherson Region.

Task description: Development of tourist infrastructure and creation of new opportunities for small and medium businesses.

Country/Place of work: Hryhorivka village, Prysyvash United Territorial Community, Chaplynskyi District, Kherson Region, Ukraine.

1. Project Background

The expected result of the pilot project on socio-economic recovery of Kherson region is the increase in the capacity of the authorities in planning and implementing crisis response measures, including post-crisis recovery of the region.

The project end points are as follows:

1. The assessment of socio-economic impact of COVID-19 at the regional level.
2. The development of effective measures for crisis response and post-crisis recovery.
3. Increasing the capacity of regional and local authorities to implement response and recovery measures.
4. Identification and implementation of local initiatives to counter and mitigate negative effects of the pandemic.

Ukraine, like all other countries in the world, is facing negative impact of the COVID-19 pandemic. This outbreak coincided with governmental changes in the country exacerbated by insufficient reform progress, a weakening health care system, an aging population, a macroeconomic downturn and a protracted armed conflict in the Eastern Ukraine. The COVID-19 pandemic has seriously affected all regions and local communities of Ukraine, in particular by further straining local budgets and worsening the results of long-term underinvestment in the health care system. In addition, administrative services are suspended or provided only in part due to a lack of local capacity, both institutional and human, to operate in these critical circumstances.

Objective: To build a stage to hold cultural and artistic events in the open air (festivals, concerts, theatre performances, etc.). Due to the lockdown in the country imposed in order to prevent the spread of the COVID-19, restrictions were imposed on the conduct of cultural events indoors. However, it is allowed to hold these events outdoors subject to the recommendations of the Chief State Sanitary Doctor (i.e. temperature screening, marking to ensure at least 1.5 metres distance and availability of sufficient number of personal protective means). It is very important to hold cultural events for the residents of the rural community, because culture has always been and remains one of the main levers in the life of society and the individual. The lack of a positive solution to the cultural problems in the countryside can lead to the catastrophe, thereby lowering the cultural level of people and leading to the decline of spiritual and moral values.

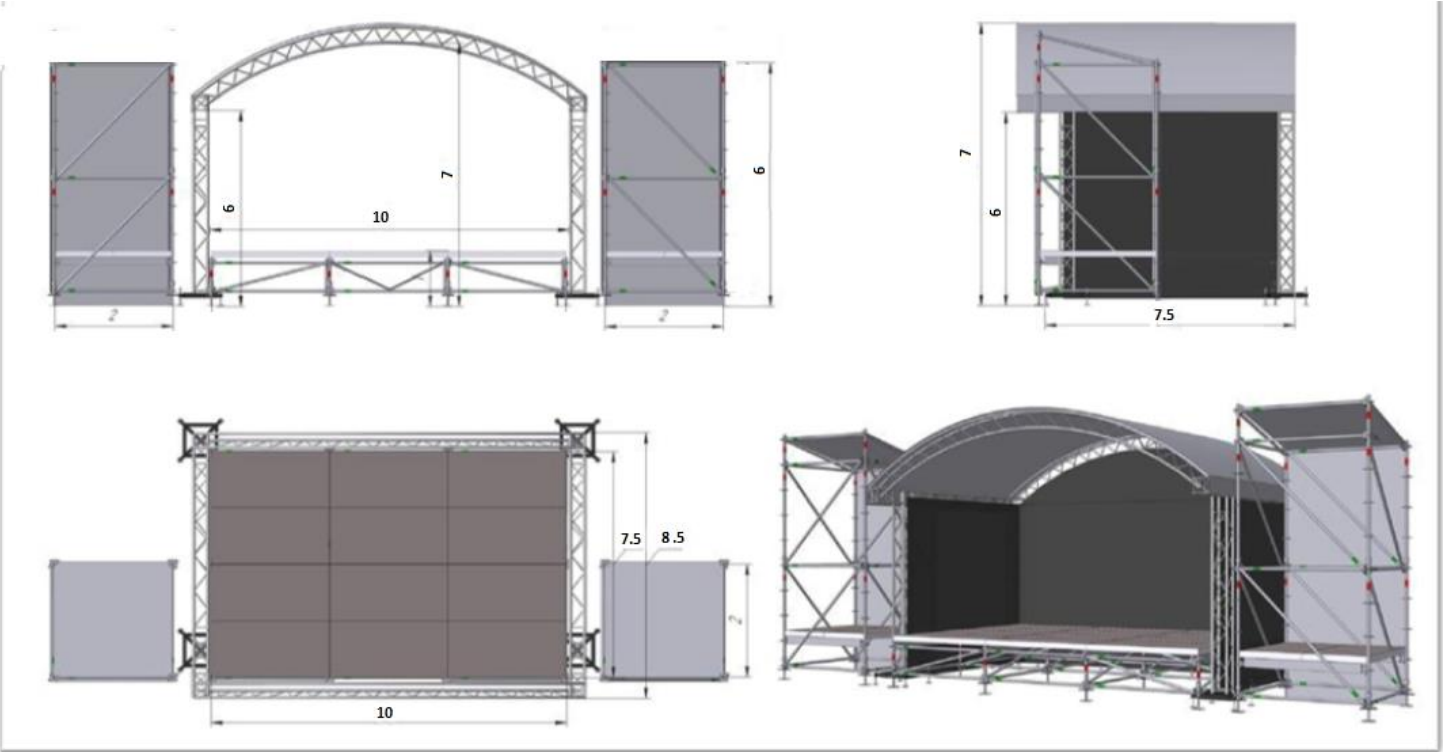
Delivery: Hryhorivka village, Chaplynskyi District, Kherson Region (the delivery is included into the price for the stage complex).

Installation works: installation works will be carried out by employees of the Municipal Enterprise “Strumok” of Prysyvash United Territorial Community (no additional funding is needed, since installation works are to be covered by the payroll budget of the municipal enterprise).

Warranty period: 1 year.

THE STAGE

1. Metalwork stage (10 * 7.5 * 6 m) - 1 pc.
2. Podium flooring - moisture resistant plywood - 75 sq.m.
3. Roof - PVC fabric - 90 sq.m.
4. Stairs with handrails - 1 pc.
5. Metalwork portals (2 * 2 * 6m) - 2 pcs.
6. Portals - PVC fabric - 30 sq.m.
7. PVC fabric podium skirt - 25 sq. m.
8. Fastening - bolted connection (is included in the stage complex set, no need for additional payment).
9. Lighting - not included in the stage complex set and will be purchased separately at the expense of Hryhorivka Village Council.
