#### I. BACKGROUND

UNDP Indonesia has been working together with the Government of Indonesia to build safer and resilient communities as well as relevant Government institutions at national and sub-national levels in normal and post-disaster settings. Many rules, regulation, tools, methodologies, and action plans on disaster risk management and post-disaster recovery had been developed with support from UNDP. It shows that the policy and legal basis for all stakeholders to undertake efforts for recovery in post-disaster setting and to reduce and increase disaster preparedness in normal setting are available in the country. At the intervention level, UNDP Indonesia has been working closely with the Government of Indonesia and affected communities for early recovery/recovery interventions. Since tsunami Aceh in 2004, there have been 13 early recovery/recovery assistances for disaster affected areas have been provided to GoI until 2018.

Additionally UNDP is in partnership with Baznas in offering an integrated zakat for SDGs programme to increase the role of zakat in supporting the SDGs. This programme also aims to strengthen the institution and to enhance zakat collection and inclusivity. The plan will be aligned with Baznas' priority in increasing agriculture literacy through partnership with vocational schools.

The project's main goal is to enhance the community knowledge and capacity to recover from disaster and reduce disaster risks as well as climate change negative impacts. The main target is to enhance the government and community's capacity in resilient recovery through provision of assistances to develop a resilient village, safer schools and livelihoods.

The opportunity is built from the good practices Baznas and UNDP have put in place, through the incorporation of innovative financing, in introducing the off-grid energy generation. One of the first outputs of a livelihood initiative would be to conduct a detailed cocoa value chain analysis to identify those with highest potential, including market (end-buyer) potential, and value-addition opportunities that can provide significant profit to the local farmers. The other output is to link the smallholders to impact ventures that can benefit famers by tackling the issues identified and create a sustainable agriculture ecosystem.

## II. SCOPE OF WORK, ACTIVITIES AND DELIVERABLE

The Community Engagement Specialist will be appointed to support UNDP - Baznas Community Resilience Strengthening Project by providing his/her technical expert to supervise community engagement. These are expected scope of works/activities that will be carried by consultant:

- a. Assisting the project to support resilient livelihood
  - Actively contribute to improve the capacity of the communities in identifying and understanding the potentials of the village regarding their livelihood, through existing project output.
  - Formulating and supporting the implementation of community recovery action plan in livelihood sector
  - Supporting village community livelihood recovery with provision of technical assistance to selected beneficiaries, including capacity building, micro enterprise assistance, job linkages, and inter sectoral linkages mechanism
  - Documenting assessment tools, learning modules and lessons learned/best practices of livelihood programme implementation
- b. Preparedness/DRR community intervention (for school)
  - Formulating disaster preparedness school as a model in which the school community can identify and understand the existing hazards that threat the school and the surrounding, vulnerability and capacity
  - Integrating disaster risk reduction initiatives in the planning mechanism and school activities, and the implementation of regular activities related to DRR initiative at school
  - Establishing and/or strengthening a school community forum as a media for exchanging information with other schools
  - Documenting lessons learnt of safer school initiatives implementation
