2. PROJECT BACKGROUND AND JUSTIFICATION

As one of the Implementing Agencies of the Global Environment Facility (GEF), UNDP is supporting developing countries to develop and implement projects aimed at the elimination and/or sustainable management of mercury to meet their obligations under the newly established Minamata Convention on Mercury.

Recognizing the multi-dimensional impacts of artisanal and small-scale gold mining (ASGM) on the environment, health and poverty, the "Global Opportunities for Long-Term Development of ASGM" (GEF GOLD) programme was approved at the October 2016 council meeting of the GEF. GEF GOLD is a programmatic approach on ASGM involving three UN agencies (UNDP, UNEP, and UNIDO) and one NGO (Conservation International). The GEF GOLD programme has a global component on communications and knowledge management, which is managed by UNEP and country-level projects in eight countries: Burkina Faso (UNIDO), Colombia (UNDP), Guyana (Conservation International), Indonesia (UNDP), Kenya (UNDP), Mongolia (UNEP/UNIDO), Peru (UNDP), and Philippines (UNEP/UNIDO).

The main objective of the programme is to achieve Global Environmental Benefits by reducing mercury releases from ASGM practices through the introduction and promotion of best practices and techniques for gold extraction.

Given the ambitious targets of GEF GOLD, in the GOLD+ was approved in the June 2020 work Programme for with CI as the lead of the global on communications and knowledge management component and eight country-level projects: Bolivia (UNIDO), Congo (UNEP), Ghana (UNDP/UNIDO), Honduras (UNDP), Madagascar (UNIDO), Nigeria (UNIDO), Suriname (UNDP), Uganda (UNEP),

With this background, and in order to support the efforts of the Governments of Honduras and Suriname to protect human health and the environment from mercury releases originating from the intentional use of mercury in ASGM, UNDP in its capacity as the Implementing Agency for the GEF, requires the support of an International Senior Gender and Financial Expert.

The International Gender and Financial Expert is expected to support the design and preparation of two (2) UNDP/GEF projects and accompanying project documents for the GEF GOLD programme in Honduras and Suriname and support the preparation of additional supporting documents required for approval by the GEF.





3. GENERAL OBJECTIVE

The role of the International Gender and Financial Expert will be two-fold 1) Provide technical assistance to national consultants who support the construction of the baseline and the other phases of the project in aspects related to financial and gender issues and 2) develop mandatory project Annexes related to application of social and environmental safeguards and support adherence of project development to UNDP's SESP and specific requirements on these two subjects, as appropriate for the two (2) GEF/UNDP projects for Honduras and Suriname.

4. FUNCTIONS

International Gender and Financial Expert will provide technical assistance to national consultants who support the construction of the baseline and the other phases of the project in aspects related to financial issues. In addition, the consultant will ensure that GEF and UNDP gender considerations are fully mainstreamed into all relevant components of the project document as well as produce a participatory gender analysis and action plan for the project. He/she will also support the international team in charge of preparing both projects documents and the related documentation for project submission to the GEF.

5. EXPECTED PRODUCTS

- For each country (Honduras and Suriname):
 - o Two (2) Gender Diagnostics, Gender Strategies, Gender Action Plans and Final Reports on Gender issues, including inputs and information to support the International Project Coordinator, including response to comments received by GEF Secretariat, and GEF Council and clearance of complete CEO Endorsement documentation.
 - o Two (2) proposals for a financial incentive structure that contributes to formalizing / legalizing ASGM activities, financial components sections from the Project Document, report with the identification the main obstacles to the financial sector granted loans to artisan mining / as of the ASGM sector, reviews of the current supply chain and identification of mechanisms to increase the potential benefit against gold market intermediaries, analysis with identification of obstacles and barriers access to different financial instruments and documents with analysis of financial needs of the ASGM sector in the pilot regions, in accordance with the financial environment in each of the countries.
 - o In coordination with the International Safeguards Specialist for ASGM, provide relevant inputs for the gender considerations of the Environmental and Social Risks Management Framework for the two (2) projects.
 - Two (2) mission reports covering the participation during the three (2 PPG consultation sessions /workshops and at least two (2) field visits to Honduras and Suriname).

6. COORDINATION AND SUPERVISION

The International Gender and Finance Expert will work in close coordination with the **International Project Coordinator**, the 2 **National Project Coordinators** and **2 National ASGM experts**. He/she will be supervised and in continuous communication with the Honduras and Suriname UNDP Country Offices and the relevant UNDP MPU/Chemicals Regional Technical Advisor(s) to facilitate the preparation of the





country projects. He/she should carry out his/her tasks in accordance with the rules and procedures of UNDP.

7. CONTRACT DURATION

The contract will run for 12 months from the signing of the contract.

8. PLACE OF WORK

The consultant shall perform his/her functions remotely. The International Gender and Finance Expert will be required to visit the project countries as outlined in the products section. One (1) one-week mission of 5 workdays for each of the project countries, are required to be undertaken by the International Gender and Finance Expert during the PPG phase.

9. EXPERT/TRAINER PROFILE

The International Gender and Finance Expert shall have the following capabilities and experience:

- Master's degree or higher in a relevant field, such as Economics, Social Studies, Development and Specialized degree in Gender studies
- At least five (5) years of experience in the development, support and management of financial structures, financing mechanisms related to environmental projects.
- At least three (3) years of experience and knowledge of the development banking sector in Latin America and the Caribbean.
- At least three (3) years of experience in financing mechanisms and financing structures related to the artisanal mining and small-scale mining sector, or in projects that promote technological improvement as a strategy for environmental management.
- Thorough experience on analysis on investment for gender development.
- Desirable experience and / or familiarity with GEF projects, UNDP or other international organizations and their processes.
- Fluent in spoken and written English and Spanish.
