# Rehabilitation of Al-Shifaa Complex Sewerage Treatment plant, Two lifting Stations & Sewerage pipe Network, West Mosul-Ninawa Governorate

#### 1. PROJECT BACKGROUND

#### a. Project description

The al-Shifaa complex Sewerage Treatment plant was constructed at the Hospital Complex in 2000-2001 to serve all the hospitals and service buildings inside the area, as well as some of the residential areas surrounding the hospital complex. The facility treats wastewater and prevents it spilling into the Tigris untreated, with health- and environmental damage as a result. UNDP is currently rehabilitating four (soon to be five) hospitals at the Shifaa complex, and other partners (GIZ, UNFPA etc) have rebuilt temporary hospitals on-site as well. Rehabilitating the wastewater facility would allow for a clean(er) treatment of waste from all these hospitals and have substantial added value. The project is for the rehabilitation of the wastewater plant, the transmission line and two lifting stations, as well as the pipes and the sewerage network.

#### **Direct and indirect beneficiaries**

The sewerage treatment plant was damaged during the liberation of the city, with damage mainly to the sedimentation tanks, equalization tank, aeration tanks, chlorine system, internal road, outside fence, electrical room, transformers and administration buildings.

#### 5. WORKS IN BRIEF:

The rehabilitation work includes civil, sanitary, mechanical and electrical items:

- 1- Civil works. This includes but is not limited to the demolition and dismantling of the damaged components and concrete, and constructing a new building for the administration (with a ground floor, first floor and guard room), chlorine system and constructing the sewerage line, manholes, internal roads and sewerage lifting stations.
- 2- Mechanical Works. Mechanical work consists of but is not limited to supplying six submersible pumps for both lifting stations, four blowers, a bridge scraper, two sludge pumps and a chlorine gas system, repairing and supplying valves, check valves, and upgrading the equalization tank and aeration tank systems from a mixing type to a diffuser type (which is more efficient.) Supply the necessary laboratory equipment to be used for operating the plant, and mechanical tools for maintenance purposes. Supplying the administration building with air conditioning units (split units.)
- 3- Electrical Works. This includes supplying and installing one transformer with an MV transmission line, one stand-by generator to power the sewerage treatment plant and auxiliary electrical systems of the building, and all items required to provide the administration, laboratory and operators' accommodation buildings and the site with electricity. Other works include but are not limited to: (1) site preparation and cleaning; (2) supplying and installing a new transformer with 250KVA and a new stand-by generator with 150 KVA (including earthing systems, inspections, erection/installation, commissioning and any required civil works); (3) supplying and installing the main electrical board; (4) supplying and installing the main control electrical board (MCC) for operating the pumps, blowers and electrical valves; (5) LT and HT cables, conduits, cable trays, and trenches; (6) lighting points, lighting poles, power socket outlets, fans, exhaust fans, CCTV etc.; (7) earthing systems and connecting to main distribution and control distribution boards.
