I. BACKGROUND

COVID 19 is having a growing dramatic impact on the health of the people of Indonesia, a country with the fourth largest population in the world. For millions of them, the epidemic also threatens employment, livelihoods and access to public services at a time when they most need them. The **human development impact of COVID 19** is strong and will be long lasting. It will be even stronger for the poor and the vulnerable, including the estimated 40 per cent of the population amounting to about 180 million people living just above the national poverty line and vulnerable to external shocks. Women, especially female headed households and women working in the large informal economy, daily workers and people with disabilities who are also facing multifold challenges in Indonesia, will be the worst affected. The economic and social impact of COVID 19 will therefore be heavy, multi-sectoral and while having immediate effects, it will also span over a medium to long period of time.

UNDP supports Indonesia and its people with immediate and longer-term response to the COVID-19 Pandemics, which is **human development centered and multi-sectoral,** as implied by UNDP's broad development mandate. As a member of the UN development system, UNDP has an important role to play in the response to the COVID 19 crisis in Indonesia. UNDP's immediate response to COVID-19 is organized in 4 main streams:

- 1. Immediate strengthening of health systems and health governance and building of their longer-term resilience.
- 2. Direct support to an inclusive and "whole of society" response for prevention and mitigation at central and local levels.
- 3. Addressing the socio-economic impacts of COVID-19 to protect the Indonesian people and safeguard progress towards the Sustainable Development Goals.
- 4. Utilizing digital solutions and big data analysis for enhanced national response.

As part of the support under stream 2, UNDP will support the Gol to establish inclusive and multisectoral crisis management and response to COVID-19. UNDP is supporting BNPB and BPBDs to conduct recovery needs assessment (JITUPASNA/PDNA) and recovery programme planning due to the COVID pandemic in 8 provinces. Support for sub-national level will also include coordination strategy for recovery processes and identification potential innovative funding for recovery. In addition to supporting national and local authorities in identifying damage, loss and recovery needs, UNDP also initiated support for subnational contingency plans, specifically for the pandemic in 7 provinces, with technical support from UNOCHA.

The JITUPASNA and Recovery Programme Planning Advisor will facilitate RESTORE Project in supporting BNPB, BPBDs and other local authorities to conduct JITUPASNA, develop recovery programme (R₃P) and develop contingency plan (CP) for COVID-19 to accelerate recovery of and strengthen preparedness of the affected communities in the target Provinces.

II. SCOPE OF WORK, RESPONSIBILITIES AND DESCRIPTION OF THE PROPOSED ANALYTICAL WORK

The Advisor is responsible for providing technical advisory input and coordination assistance for the implementation of JITUPASNA, R₃P and CP planning processes. He/she will work under the direct supervision of National Project Manager of RESTORE Project and working in close collaboration with Resilience and Reconstruction Unit, other programme units of UNDP Indonesia CO and respective projects, operations team of the CO, technical advisors, experts, Government officials, and other relevant stakeholders to successfully implement a coherence UNDP immediate response and assist the CO to pave a way to support Gol toward the medium and longer-term recovery for COVID-19.

The Advisor will deliver the output through an extensive consultation with various stakeholders at national and regional level that consists of representative of practitioners, experts, local governments and NGO's. The consultant is expected to accomplish the following:

- Facilitate BNPB and BPBDs to establish the institutional management framework of COVID-19 needs assessment, recovery programme planning and contingency programme planning at the target provinces.
- Maintain close coordination with national and subnational stakeholders and establish partnership to support implementation of activities.
- Provide technical advisory support and coordinate the organization of recovery needs assessment, development of its recovery programme and development contingency plans.
- Provide advice and facilitate coordination to encourage active engagement of wider stakeholders including UN Agencies toward overall activities as necessary.
- Involved in coordination meetings, forums and other relevant events and provide information in the areas of UNDP supports.
- Provide advisory and advocacy for and strengthening of national capacity for planning and coordination of the recovery effort.
- Facilitate the NPM on planning, budgeting, implementing and monitoring of the activities under this advisory assignment.
- Proactively identifying technical development needs and opportunities as well as facilitate RESTORE project for the development of strategic partnerships and resource mobilization for recovery.
- Advise BNPB and RESTORE Project PMU on viable strategies, timeline and tools for related to the above subject within the BNPB and GoI structure with special focus on long-term capacity building.
- Ensures alignment and coordination of recovery programme with other programme activities of the CO as well as those of UN Agencies and capitalizes on synergies where possible.
- Ensures mainstreaming of cross-cutting UN/UNDP priorities in recovery programmes, in particular environment, gender, human rights and disaster risk reduction.
- Provision of top-quality policy and strategic advice to Government on development and implementation of recovery policies and strategies.
- Bringing best practices in the handling of the pandemic COVID-19 that has been done by UNDP and the Government of Indonesia, in this case the ministry in collaboration with the UNDP in regional and international forums.
- Bringing best practice based on regional/international action plan against COVID-19 recovery process.
