# **Section 2.** Instruction to Bidders

A. GENERAL PROVISIONS		
1. Introduction	1.1	Bidders shall adhere to all the requirements of this RFP, including any amendments in writing by UNDP. 	1.2	Any Proposal submitted will be regarded as an offer by the Bidder and does not constitute or imply the acceptance of the Proposal by UNDP. UNDP is under no obligation to award a contract to any Bidder as a result of this RFP.
	1.3	As part of the bid, it is desired that the Bidder registers at the United Nations Global Marketplace (UNGM) website ( <a href="www.ungm.org">www.ungm.org</a> ). The Bidder may still submit a bid even if not registered with the UNGM. However, if the Bidder is selected for contract award, the Bidder must register on the UNGM prior to contract signature.
2. Fraud & Corruption, Gifts and Hospitality	2.1	UNDP strictly enforces a policy of zero tolerance on proscribed practices, including fraud, corruption, collusion, unethical or unprofessional practices, and obstruction of UNDP vendors and requires all bidders/vendors observe the highest standard of ethics during the procurement process and contract implementation. 3. Eligibility	3.1	A vendor should not be suspended, debarred, or otherwise identified as ineligible by any UN Organization or the World Bank Group or any other international Organization. Vendors are therefore required to disclose to UNDP whether they are subject to any sanction or temporary suspension imposed by these organizations.
	3.2	It is the Bidder's responsibility to ensure that its employees, joint venture members, sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by UNDP.

#### 4. Conflict of Interests

4.1

- Bidders must strictly avoid conflicts with other assignments or their own interests, and act without consideration for future work. Bidders found to have a conflict of interest shall be disqualified. Without limitation on the generality of the above, Bidders, and any of their affiliates, shall be considered to have a conflict of interest with one or more parties in this solicitation process, if they:
  - a) Are or have been associated in the past, with a firm or any of its affiliates which have been engaged by UNDP to provide services for the preparation of the design, specifications, Terms of Reference, cost analysis/estimation, and other documents to be used for the procurement of the goods and services in this selection process;
  - b) Were involved in the preparation and/or design of the programme/project related to the services requested under this RFP; or
  - c) Are found to be in conflict for any other reason, as may be established by, or at the discretion of UNDP.
- 4.2 In the event of any uncertainty in the interpretation of a potential conflict of interest, Bidders must disclose to UNDP, and seek UNDP's confirmation on whether or not such a conflict exists.
- 4.3 Similarly, the Bidders must disclose in their proposal their knowledge of the following:
  - a) If the owners, part-owners, officers, directors, controlling shareholders, of the bidding entity or key personnel are family members of UNDP staff involved in the procurement functions and/or the Government of the country or any Implementing Partner receiving services under this RFP; and
  - b) All other circumstances that could potentially lead to actual or perceived conflict of interest, collusion or unfair competition practices.

Failure to disclose such an information may result in the rejection of the proposal or proposals affected by the non-disclosure.

4.4 The eligibility of Bidders that are wholly or partly owned by the Government shall be subject to UNDP's further evaluation and review of various factors such as being registered, operated and managed as an independent business entity, the extent of Government ownership/share, receipt of subsidies, mandate and access to information in relation to this RFP, among others. Conditions that may lead to undue advantage against other Bidders may result in the eventual rejection of the Proposal.

#### **B. PREPARATION OF PROPOSALS**

### General Considerations

- 5.1 In preparing the Proposal, the Bidder is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal.
- 5.2 The Bidder will not be permitted to take advantage of any errors or omissions in the RFP. Should such errors or omissions be discovered, the Bidder must notify the UNDP

# 6. Cost of Preparation of Proposal

6.1 The Bidder shall bear any and all costs related to the preparation and/or submission of the Proposal, regardless of whether its Proposal was selected or not. UNDP shall not be responsible or liable for those costs, regardless of the conduct or outcome of the procurement process.

### 7. Language

- 7.1 The Proposal, as well as any and all related correspondence exchanged by the Bidder and UNDP, shall be written in the language (s) specified in the BDS.

In order to award a contract to a Bidder, its qualifications must be documented to UNDP's satisfaction.		
10.Technical Proposal Format and Content	10.1 The Bidder is required to submit a Technical Proposal using the Standard Forms and templates provided in Section 6 of the RFP.		
	10.2 The Technical Proposal shall not include any price or financial information. A Technical Proposal containing material financial information may be declared non-responsive.		
	Samples of items, when required as per Section 5, shall be provided within the time specified and unless otherwise specified by UNDP, and at no expense to UNDP		
	When applicable and required as per Section 5, the Bidder shall describe the necessary training programme available for the maintenance and operation of the services and/or equipment offered as well as the cost to the UNDP. Unless otherwise specified, such training as well as training materials shall be provided in the language of the Bid as specified in the BDS.		
11. Financial Proposals	11.1 The Financial Proposal shall be prepared using the Standard Form provided in Section 6 of the RFP. It shall list all major cost components associated with the services, and the detailed breakdown of such costs.		
	Any output and activities described in the Technical Proposal but not priced in the Financial Proposal, shall be assumed to be included in the prices of other activities or items, as well as in the final total price.		
	Prices and other financial information must not be disclosed in any other place except in the financial proposal.		
12. Proposal Security	12.1 A Proposal Security, if required by BDS, shall be provided in the amount and form indicated in the BDS. The Proposal Security shall be valid up to thirty (30) days after the final date of validity of the Proposal.

## **Section 5.** Terms of Reference

#### A. BACKGROUND INFORMATION

The United Nations Development Programme (UNDP) and the United Nations Capital Development Fund (UNCDF), through a joint programme with the United Nations University Institute for Environment and Human Security (UNU-EHS), and in close collaboration with key stakeholders from the government, public, private sector and other development partners, aims to address the challenges of post disaster financing through the workstreams envisaged in the Pacific Insurance and Climate Adaptation Programme, henceforth referred to as "the Programme". The Programme has an inception phase of 2 years and will focus on building climate disaster resilience in Fiji and Vanuatu through innovative, inclusive insurance products/services and climate disaster risk financing (CDRF) instruments, including human centric product design, targeted insurance awareness and capacity building, and digital literacy campaigns.

The Programme is aligned to the United Nations Pacific Strategy, UNCDF global strategies and the respective country national development plans.

#### B. OBJECTIVES:

Through the Programme, specific attention will be given to the development and implementation of innovative CDRF products and services, including parametric insurance, that will improve the financial preparedness of households, communities, small businesses, organisations and governments towards climate change and natural hazards in Fiji and Vanuatu, through a combination of stakeholder engagement, cocreation of solutions, awareness and capacity building, innovative financing options and digital linkages – with a robust interface to the 2030 Sustainable Development Goals.

Specific attention will be given to the development of the right services to empower and target **key customer segments** (women, youth, and micro-small-and medium-sized enterprises (MSMEs)) and the Programme will work across **key sectors** such as Agriculture, fisheries, retail and tourism.

The objective of these terms of reference is to identify and select high quality contractors capable of providing technical assistance to the Programme and partners for reliable, agile and efficient delivery of Programme outputs.

#### C. SCOPE OF WORK

#### **EMPOWERED CUSTOMERS**

The contractors are to provide advisory services for skill building, creating awareness, outreach and customer education knowledge products in the field of insurance, CDRF and InsurTech, microfinance, pensions for the Programme and partners. A key focus is the development of soft and hard skills of customers, using a combination of services (digital and non-digital) that accelerates understability, usability and economic empowerment of women, youth and MSMEs, covering insurance, CDRF instruments and InsurTech products and services.

#### **SCOPE OF THE SERVICES REQUIRED**

Conduct deep-dive thematic research on Insurance, CDRF and InsurTech digital solutions. The contractors will assist partners, including private sector, government institutions and regulators in understanding the challenges and opportunities present in digital and financial literacy and subsequently developing appropriate awareness and knowledge products to improve digital and financial literacy capabilities of customers, particularly towards insurance, CDRF instruments and InsurTech and also making them available on digital platform.

### **Expected Outputs:**

- Gap analysis.
- Strategies and roadmaps for the development in financial literacy and digital literacy, particularly for insurance, CDRF instruments and InsurTech.
- Educational and literacy material development for target segments and sectors as appropriate
- Training curricula adaptation to use digital as a delivery channel.
- Implementation plans.

**Provide technical assistance to the Programme's partners on project implementation.** In line with its policies and procedures, the Programme solicits and appraises proposals from institutions for technical and/or financial support. The Programme then concludes technical assistance, grant or loans agreements with selected partners.

Trainings may also encompass activities such as workshops, orientation events, convening events, seminars or peer exchange trips.

- Workshops with key stakeholders.

**Knowledge generation & sharing.** Respond to specific requests from the Programme regarding knowledge generation.

- Dashboards, websites material, blogs, video, infographics and social media materials, etc.

#### D. EVALUATION CRITERIA

#### F. DUTY STATION
