- File names must be maximum 60 characters long and must not contain any letter or special character other than from Latin alphabet/keyboard.
- All files must be free of viruses and not corrupted.
- Max. File Size per transmission: 35 MB and no more than five email
- Mandatory subject of email: UNDP-TUR-RFQ(KR)-2020/56 “ Supply of Solar Power Plant (GES) Equipment/Materials”
- Multiple emails must be clearly identified by indicating in the subject line “email no. X of Y”, and the final “email no. Y of Y.”

It is recommended that the entire Quotation be consolidated into as few attachments as possible.

**Please clarify that what type of Energy Analyzer is required (hand carrying unit or in panel).**

**ANSWER 2:**

“Energy Analyzer” specified in item 19 of Technical Specifications is panel type. However, “Portable Energy Analyzer (hand type)” which meets the Technical Specifications defined in RFQ shall be also acceptable.
