### **ANNEX 1: SCHEDULE OF REQUIREMENTS**

#### SPECIFICATION

#### on the computer equipment for the schools of Donetsk and Luhansk oblast

#### 1. Context

The United Nations Recovery and Peacebuilding Programme (UN RPP) is implemented by four UN agencies: the United Nations Development Programme (UNDP), the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women), the United Nations Population Fund (UNFPA), and Food and Agriculture Organization of the United Nations (FAO).

The programme is supported by twelve international partners: the European Union (EU), the European Investment Bank (EIB), and the governments of the Canada, Denmark, Germany, Japan, the Netherlands, Norway, Poland, Switzerland, Sweden and the United Kingdom.

Component III "Community Security and Social Cohesion" (CSSC) of UN RPP aims to achieve some of its objectives by enhancing community security; supporting civic mobilization and empowerment of communities; reconciliation and restoration of social cohesion.

As a part of building a cohesive society, Component III takes steps for promoting ICT solutions in education sphere. The restrictions imposed by COVID-19 have created significant barriers to access to education for children. Moreover, they significantly reduced the opportunities for direct communication and interaction among children and adolescents. As a result, the relevance and demand for online tools is growing rapidly. Moreover, children from non government controlled areas are studying remotely in the schools among the contact line. At the same time, communities near the contact line, rural communities cannot provide digitalization technically due to the local budget deficit and limited government funding. Considering the specialties of the geographical location and socio-economic conditions of the settlements of Donetsk and Luhansk oblasts near the contact line, it is necessary to create conditions for implementation of ICT solutions to facilitate educational process and create more cohesive school society.

To respond to the described challenges, the Ministry of Education of Ukraine is launching the All-Ukrainian experiment "Implementation of the My School System in Educational Institutions". The project plans to work with the My School platform, which offers a comprehensive system for the digitalization of school business processes. In terms of functionality, the system makes all business processes paperless and makes online learning much easier. Moreover, it helps school community to be more cohesive by providing a digital platform for engaging in class or school projects, discussing, proposing, expressing opinions, sharing achievements, etc.

In this regard, UN RPP is planning to support school digitalization in Donetsk and Luhansk oblast by purchasing the computer equipment and its delivery to three schools in rural localities in Donetsk oblast (Volnovakha rayon, Valerianivske, GCA) and Luhansk oblast (Shchastia, Krasnorichenske, GCA).

#### 2. Scope of work

Delivery of computer room equipment to schools according to the Technical specification, contained in the Table 1, Table 2, Table 3 and to the Addresses, specified in the Table 4.

• the column "Comprised on the operation, exempted from taxation" on the upper left part - with the mark "Without VAT";

• Section A of the TI table section (lines I-X) should contain the summarizing data on TI transactions, namely: line I - the total amount to be paid, including VAT; line IX - the total volume of goods and services delivered. Lines II-VIII of section A are not filled;

• in column 2 of section B – supplier's (seller's) services nomenclature;

• in section 3.3 of section B - service code according to the SCPS. Box 3.3 should be filled in at all stages of the services delivery;

- in columns 4 and 5 unit of services measurement;
- in column 6 quantity (volume) of services delivery;
- in column 7 the price of the service unit supply, excluding VAT;
- in column 8 VAT rate code 903;

• in column 9 – tax allowance code according to the Handbook of other tax benefits, approved by the SFS as of the date of TI submission - "14060523".

• in column 10 - supply volume, excluding VAT (prepayment amount).

Detailed instructions to be found in the materials "Tax invoice - 2017: instruction on filling out" and "New tax invoice in the samples."

*Credit against VAT tax, applied on the materials purchase for the relevant construction works performance, cannot be compensated as per the paragraph #198.5 of Tax Code of Ukraine. According to the Tax Code paragraph #198.5, goods* 

and services supply operations, exempted from VAT based on the Tax Code paragraph #197.11, the rules for calculating tax liabilities do not apply.

Using the materials bought with VAT, there is no need to compensate the credit against VAT, as well as no need to accrue tax liabilities.

*Considering all mentioned above, you are kindly asked to submit your tender applications / invoices for payment without VAT, referring to the Ukrainian legislation provisions, stated in the mentioned regulatory acts.*
