- 3. Completed Financial Proposal
- 4. Completed technical proposal
  - a) To provide approach and methodology that show a strong theoretical and practical background in graphic / visual communication design, including the use of design software such as Adobe Photoshop, Adobe Premier, In-Design, CorelDraw, web design tools such as Dreamweaver, After Effect for Videos, and Adobe XD for Web Design. (This is proved by attaching sample of design in a softcopy or (preferably) website link, or any social media link.)

# 2. FINANCIAL PROPOSAL

### Lump sum contracts

The financial proposal shall specify a total lump sum amount, and payment terms around specific and measurable (qualitative and quantitative) deliverables (i.e. whether payments fall in installments or upon completion of the entire contract). Payments are based upon output, i.e. upon delivery of the services specified in the TOR. In order to assist the requesting unit in the comparison of financial proposals, the financial proposal will include a breakdown of this lump sum amount (including travel, per diems, and number of anticipated working days).
