Q 1: As the Strengthening Rural-Urban Linkages is a novel project for Georgia could you please confirm that it refers to the Strengthening Economic linkages, in particular, there may be an agricultural hub in the rural area and the winning company should determine how it can be added to the existing urban networks?

Answer: Partially this announcement serves to support the activities described by you. However, the overall purpose of this assignment is more comprehensive than that specific. For Instance, Kobuleti and Batumi Municipalities may have separate programs for economic development, and the winning company should find out the ways to link them. Please note that in the announced RFP 2 guidelines are indicted one is UNDP guideline another one is OECD. I would strongly recommend reviewing those documents to have a clearer understanding of the tasks.
