Ms. Enkhmandakh Ishdorj welcomed the participants and expressed her appreciation for their interest in the announced bidding and presence in the pre-proposal conference. Then, she passed the floor to Mr. Mohammad Anakrih, Livelihood Specialist, to provide a brief background on the project and requirement of the Terms of Reference.

Mr. Mohammad Anakrih, gave a detailed information on the project objectives and expected outputs under the TOR. The COVID19 has affected different sphere of life including SME sector. This project aims to support SMEs either to restore business operations or establish new business ideas that contribute to both digital and green economy sectors.

One of examples of the green economy could be recycling as a business idea, where the entrepreneur could do recycling of plastic and produce internal decoration materials to sell, etc. There's a chance to support the youth of Iraq in Muthana to come up with creative business ideas under the green economy umbrella. Digitalization and IT tends to be very efficient tool to maintain businesses and operations during COVID19 for several organizations, e.g. Online delivery, IT logistics. Existing businesses that aim to digitalize or automize some of their business operations to upgrade or grow in order to sustain its business.

The selected Organization is expected to carry out community outreach to mobilize the selection of 28 men and women beneficiaries based on a pre-identified eligibility and selection criteria that will be developed based on vulnerability and poverty criteria that will be developed in close consultation with UNDP team. The 28 selected beneficiaries will receive an "Enterprise Support Package for New or Existing Businesses" through a three-pronged approach; i) business skills development, ii) grants/toolkits/asset replacement, and iii) mentorship and networking support (B2B) to support sustainability and profitability.

The TOR explains the methodology, activities under each output, project duration which is maximum 6 months, eligibility criteria as well as scope of technical and price proposal. Its important to pay attention to the core team requirements and CVs should align the qualifications stated per each core team members. The technical and price proposals shall be evaluated against the criteria set in the CFP, so, please make sure to provide complete and comprehensive proposal. The maximum budget ceiling is provided in the CFP which should not exceed.

The specific requirements related to the subject CFP were highlighted in detail in order for bidders to fully understand the UNDP requirements. The following points were emphasized:

- The tender is conducted through eTendering module, thus, the bidders are who registered in the system, will have an access to all documentations related to this CFP and will be able to submit your offers.

- Offerors are reminded to observe the deadline set in the system and other submission requirements. The detailed user guide along with resource webpage was shared with all the bidders through the UNGM, Procurement Notice and eTendering Portal.

- Special attention is to be paid to the list of Required Documents and Annexes A, B, C.

This is the bidder's responsibility to ensure the complete submission of all necessary documents and information to enable its offer to pass/satisfy the requirements. A strong emphasis was made on the Quality and Completeness of the documentations, use of provided forms and ensuring the technical and financial offers are presented in compliance with the requirements set in the CFP.

- The evaluation criteria are explicitly listed in the CFP and bidders are strongly advised to carefully review them and submit their offers fully responding to the criteria stipulated. All bidders will be assessed against the eligibility and qualification requirements, then will further be evaluated in accordance with the detailed technical evaluation criteria.

Before opening the floor for questions, Ms. Enkhmandakh Ishdorj answered to questions received via email as follows:

Q: Could we have a specific age of beneficiaries?

A: There's a minimum cross cutting requirement, one of which is gender. In terms of age, household situation, etc. these should be developed by the winning organization in consultation with UNDP, we called it "Eligibility and selection criteria". It is expected that the organization advises on the applicable age group to be applied, what is the household situation, household income, etc.

Q: New materials used in agriculture can be considered as green?

A: Yes, applying new technics and methodologies in the agriculture to promote green economy is a part of it. Its called agribusiness.

Ms. Enkhmandakh Ishdorj underlined the importance of the thorough review of the CFP, TOR and other requirements downloading them from etendering portal and submission of the fully responsive proposal as per requirements stipulated in the CFP.
