- ✓ Statement of satisfactory Performance (Certificates) from the top 3 clients in terms of Contract value in similar field;
- ✓ Completed and signed CVs for the proposed key Personnel;
- ✓ Construction Work Schedule for the project
- ✓ List of Construction Equipment possessed by the Company;
- ✓ Written Self-Declaration of not being included in the UN Security Council 1267/1989 list, UN Procurement Division.



Preliminary Examination Criteria

MINIMUM EXPERIENCE

SIMILAR NATURE OF WORKS

AVAILABILITY OF RESOURCES (FINANCIAL /HUMAN RESOURCES /EQUIPMENT ETC)



Evaluation Criteria Guidelines

Eligibility and Qualification of the Bidder will be evaluated against the Minimum Eligibility/Qualification requirements specified Evaluation Criteria.

In general terms, vendors that meet the following criteria may be considered qualified: They are not included in the UN Security Council 1267/1989 Committee's list of terrorists and terrorist financiers, and in UNDP's ineligible vendors' list;

They have a good financial standing and have access to adequate financial resources to perform the contract and all existing commercial commitments,

They have the necessary similar experience, technical expertise, production capacity, quality certifications, quality assurance procedures and other resources applicable to the supply of goods and/or services required;

They are able to comply fully with the UNDP General Terms and Conditions of Contract; They have a record of timely and satisfactory performance with their clients.



EXAMPLES OF RFQ REJECTION

- Late submission. The RFQ is handed in after the deadline for submission.
- RFQ not submitted to the correct email address;
- Reference and Marking Instructions not adhered to.
- The RFQ not properly signed as per Solicitation Documents and mandatory forms not completed
- Insufficient documents have been provided;
- Documents provided does not directly address each point of the evaluation Criteria;
