I. BACKGROUND

Ecological Fiscal Transfer (EFT) is an all-embracing instrument in that it involves transfers of general and specific-purpose as well fiscal transfers built on arrangements of revenue-sharing. It is ecological since the very idea of the instrument is to allocate fiscal resources to relevant jurisdictions for the realization of ecological public purposes at this level of government.

In north Kalimantan, the transfer was arranged from the province to the district using certain criteria. They are (1) fire prevention in the land for other use (APL), (2) provision of green space, (3) waste management, (4) protection on water resources, and (5) air pollution prevention. The provincial government also institutionalized this transfer through Governor Regulation no 6/2019.

The government allocates Transfer to Regions and Village Funds in 2020 amounting to 34% of the total state expenditure which reaches \$180,6 billion. The total transfers to the Regions and Village Funds in the state expenditure and budget plan (RAPBN) for year 2020 are \$61,3 billion. This figure is an increase of 5.45% compared to the 2019 State Budget of \$58,1 billion. In detail, the allocation of Transfers to Regions in the RAPBN FY2020 amounted to \$56,2 billion, an increase of 3.97% from the previous year which amounted to \$54 billion, the increase in the budget is not as big as last year's 7.17%. The same thing also happened to the Village Fund allocation, which increased not as big as before, namely only 2.86% compared to the increase in the previous year which reached 16.67%. In the RAPBN FY2020, the Village Fund allocation is \$5,14 billion, up 2.87% from 2019 which amounted to \$5 billion. (\$1 = IDR 14.000)

BIOFIN project will support facilitation of ecological fiscal transfer implementation at regional government mainly from the provincial government to the district and/or from the district to village level. Determining environmental/biodiversity criteria is instrumental to operationalize effective transfer mechanism as well as ensuring the criteria are measurable. This will be mediated through intense policy advocacy and multilevel government's capacity building.

II. SCOPE OF WORK, ACTIVITIES, AND DELIVERABLES

The consultant will work with the Expert for Ecological Fiscal Transfer, the BIOFIN Project Management Team, Environment Directorate, Bappenas and UNDP Adviser for Climate and Environmental Natural Governance. The consultant will ensure smooth coordination with key Government of Indonesia institutions to support pilot testing Ecological Fiscal Transfer.

Scope of work of the assignment is as follows:

- As a point of contact and bridging between the project with the Directorates at Bappenas
- Ensure regular updates on BIOFIN project progress reported the Directorate Environment, Bappenas
- Engage with senior level of government and project stakeholders to ensure that the BIOFIN Project is in line with the national and sub-national priorities and is developed and sustained in a consultative manner
- Support implementation of a financial solution Ecological Fiscal Transfer
