#### I. BACKGROUND

Ghana's vulnerability toward the growing threat of terrorism and violent extremism marauding its nearby West Africa states is driven by several factors. First is the political vigilantism, the increased use of youth groups who are non-state actors to perform as de facto state agents or to challenge statutory security institutions or at other times act as private security/ guards creates an environment of lawlessness and insecurity. Another factor is the high unemployed frustrated youth, who are becoming vulnerable to exploitation by political actors, who used them to perpetuate violence and to human traffickers, migrant smugglers, extremists, and terrorist recruiters.

# III. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS <a>a. Academic Qualifications:</a>

A minimum master's degree in social sciences with a focus on peace and conflict studies, international relations, political science, development studies or a related field.

#### **Experience:**

- A minimum of years of progressively responsible experience in designing and implementing local level and/or national level conflict analysis mechanisms and early warning programs related to conflict affected environments;
- Extensive experience in strategy and programme development;
- Experience working with CSO's and communities.

#### IV. DOCUMENTS TO BE INCLUDED WHEN SUBMITTING THE TECHNICAL PROPOSALS

Interested offeror/Individual Consultant (IC) must submit the following documents before the deadline stipulated in the IC Procurement Notice. Such documents are:

#### V. FINANCIAL PROPOSAL

#### LUMP-SUM CONTRACTS

The Financial Proposal shall specify a total lump-sum amount **all-inclusive**, and payment terms around specific and measurable (qualitative and quantitative) deliverables (i.e. whether payments fall in installments or upon completion of the entire contract). Payments are based upon output, i.e. upon delivery of the services specified in the TOR. In order to assist the requesting unit in the comparison of financial proposals, the financial proposal will include a breakdown of this lump-sum amount (including travel, per diems, and number of anticipated working days).

#### Travel:

 <u>All envisaged travel costs must be included in the financial proposal</u>. This includes all travel to join duty station/repatriation travel. In general, UNDP should not accept travel costs exceeding those of an economy class ticket. Should the IC wish to travel on a higher class he/she should do so using their own resources.

In the case of unforeseeable travel, payment of travel costs including tickets, lodging and terminal expenses should be agreed upon, between the respective Business Unit (BU) and Individual Consultant, prior to travel and will be reimbursed.

#### VI. EVALUATION

Upon the advertisement of the Procurement Notice, qualified Individual Consultant is expected to submit both the Technical and Financial Proposals. Accordingly, Individual Consultants will be evaluated based on Cumulative Analysis as per the following scenario:

- Responsive/compliant/acceptable, and
- Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. In this regard, the respective weight of the proposals are:
  - a. Technical Criteria weight is 70%
  - b. Financial Criteria weight is 30%
