I. BACKGROUND / PROJECT DESCRIPTION

The Government of The Gambia, in partnership with the United Nations Development Programme (UNDP), is in its third year of collaboration with the Rule of Law, Justice, and Security Sector. The UNDP RoL project endeavors to implement a holistic and comprehensive program that addresses both the supply and demand sides of justice delivery. The project seeks to strengthen the rule of law institutions to deliver quality services, empower citizens to exercise their rights and increase access to justice.

The UNDP RoL project completed thorough consultations with the Ministry of Justice, the Judiciary, the Gambia Police Force, the Gambian Prisons Service, the National Agency for Legal Aid (NALA), the ADR Secretariat, the Law School of the Gambia, and the Gambia Bar Association to understand better the issues and challenges for strengthening the rule of law and increasing access to justice. Subsequently, the project board has approved the project's 2019, 2020, and 2021 Annual Work Plans.

In 2019, the Gambia Police Force (GPF) requested the UNDP RoL Project to re-initiate a Community Policing program. UNDP continues its support to Community Policing amidst the Coronavirus outbreak. In 2020, the project supported the Police in integrating and aligning the Quarterly Crime Statistics Template to the existing digital Case Management System, including operationalizing the system, developing Mobile App, and mapped out all Police posts, districts, and stations across the country. The applications will allow the Police to better plan deployments, training and allocate scarce resources based on up-to-date evidence, data, and statistics.

II. SCOPE OF THE WORK

In 2019, the UNDP RoL Project and the Gambia Police Force (GPF) identified the need to develop a case management system to support Police modernization. In 2020, the project supported the training and mentorship program for the Case Management System's operationalization and the development of a Mobile App for crime reporting. Following the Mobile App's development with the four most reported crimes with the ongoing successful pilot, the project and the Gambia Police Force agreed to upgrade the Mobile App with all reported crimes and expand to other Police stations across the country. This will be done using a phased approach with priority to the selected

community Policing areas to ensure proper personnel training, ICT capacity, and troubleshooting of the software. The UNDP Accelerator Lab would provide technical support in the upgrade of the Mobile App.

- Develop a mobile application that synchronizes with the main CMS systems
- Implement a data synchronization feature to update app and the CMS in real-time
- Develop an offline feature to allow officers to use the app without stable internet connection
- To preserve the integrity, ensure that the app would allow users with different layers of security access and rights
- Must include the design (logo) features for the Gambia Police Force
- Must be able to operate on hybrid/native apps for both iOS and android platforms The Consultant would be responsible for upgrading the mobile application to align with the digitalized case management system for evidence reporting and facilitate the decision-making process. The mobile application would allow everyday police officers to Collect and input data, and view information on reported cases in real-time while being uploaded into the CMS.
- Develop training manual to align with the digitalized case management system
- The consultant would provide training sessions to the relevant personnel following strict COVID-19 guidelines at the Headquarters, selected regional and field offices, including traffic officers in decentralizing data input. The selected office's relevant personnel would be trained on how to input and upload the data into the App to align with the Case Management System (CMS).
- The mobile application would enable the relevant officer to input data offline and upload the information into the centralized CMS system. As this is still in its pilot phase, priority should be given to police stations with ICT capacity.
- The consultancy firm would work with GPF personnel and leadership, UNDP RoL, Accelerator Lab to upgrade the mobile application for use by police personnel. The application will be owned by the Gambian Police Force.
- The consultant in collaboration with the Gambian Police Force provide 5 days training and 10 days mentorship program on the mobile application to 20 Police Officers.
