All equipment and components must be of the required level of technology, new, and according to specifications. Furthermore, all equipment and components must respond to current quality standards in international markets, be manufactured by reputed and consolidated international brands, be fully adequate to the use, and prove reliable and fully compatible as a system.

No installation is required to be done by the supplier

All equipment should have internationally recognized standards/environmental certificates (ISO 9000 certificates or equivalent)

Warranty period for all the delivered equipment and devices should be not less than 3 years since the date of delivery, including services to support the software. The applicant must provide information on warranty conditions if applicant is a manufacturer of the equipment or official dealer or must submit the documents specifying the procedures.

The proposed solution should provide most energy efficient and effective levels of performance.

Upon delivery provider must provide accurate serial numbers for major components. Serial numbers must be provided in electronic format (MS Excel or MS Access).

The documentation on the equipment should contain technical characteristics with the indication of at least all the parameters presented in the given announcement. All information and documentation must be in English language.
