TERMS OF REFERENCE

THE PROVISION OF STATIC SECURITY SERVICES FOR THE UNITED NATIONS OFFICES LOCATED IN CHAMAN HOUSING SCHEME- QUETTA

The provision of static security services for the United Nations -Quetta

Address: Chaman Housing Scheme (CHS), Airport Rd, Quetta **Building tenants:** UN Agencies offices and 02 guest houses

Security services required for: UNDP, UNHCR, UNICEF, WFP, FAO, UNESCO, UNWOMEN, UNOCHA,

WHO and UNDSS offices and in addition UNHCR and UNICEF guesthouses.

MAIN PURPOSE

The primary responsibility for the security and protection of personnel employed by the United Nations system organizations, their eligible family members and property rests with the host government. Based on this understanding the government of Balochistan provides 02 Balochistan Constabulary platoons for the protection for the UNAFPs located in the CHS. The company will be responsible for the disbursement of payments to the Balochistan Constabulary.

In return, the UNAFPs have agreed voluntary to provide food allowance to the deployed police officers', pay rent and utilities as an incentive.

SCOPE OF WORK

The objective of this TOR is to obtain services from Balochistan Constabulary of 24-hour protection to the UNFPOS and 02 guesthouses at Chaman Housing Scheme, Quetta. The company will be responsible for the disbursement of payments to the Balochistan Constabulary.

The purpose of their presence is to:

- 1. Enhance better protection of the UNAFPOs in the Chaman Housing Scheme (CHS) as a static post at the eight check posts established on the streets leading to the CHS.
- 2. Enhance smooth and timely flow of information through the detachment to the CCPO office and command post for any emergency backup if and when required.
- 3. Control access to the UNCHS and discourage and prevent unnecessary entry into the UNCHS enclave.
- 4. Stand guard at each of the check posts (x8) on 24/7 basis in three shifts
- 5. Serve as first responders (x10)

6. The size of the detachment is to be not less than 50 but not more than 60 personnel in order to adequately man the check posts and for the off duty officers to be on standby to act as first responders to any security situation.



PAYMENT PROCEDURES

- 7. UNDSS FSA monitors deployment of police and prepares attendance sheet with names and CNIC numbers. Based on the attendance sheet the FSA raises an invoice for the FSCO's approval for payment.
- 8. The approved invoice will be provided to the security company to request UNDP for the release of payment.
- 9. As soon as the money is received by the company each police officer will be paid accordingly. (Cash payment is more feasible because most of BC personnel don't have bank account and they prefer to be paid in cash.)

Price Schedule

Each Baluchistan Constabulary will be paid PKR 200 per day. Bidders are requested to quote for monthly management fees for the disbursement of payment to the Balochistan Constabulary.
