

# TERMS OF REFERENCE (ToR) FOR THE RECRUITMENT OF INDIVIDUAL CONTRACTOR (IC)

#### **GENERAL INFORMATION**

Services/Work Description:	Recruitment of Individual Consultant to develop technical specifications for CHPS medical equipment and Mobile Laboratories.

#### I. BACKGROUND

COVID-19 was declared a global pandemic by the World Health Organization (WHO) in March 2020. Since then, COVID-19 has affected practically all countries with very few exceptions. As at 3 May 2021, there were over 150 million cases and over 3 million deaths globally<sup>1</sup>. The first confirmed COVID-19 case in Ghana, was reported in March 2020 and as at 3 May 2021, over 90,000 cases had been reported. COVID-19 has disrupted almost all aspects of life including, livelihoods, economies, public health system etc. A recent WHO survey revealed that COVID-19 has partially or completely disrupted health services in many countries.<sup>2</sup>

Disruption of health services affects all persons but especially the most vulnerable including women and children. COVID-19 has also exposed, and in some instances magnified already existing vulnerabilities for persons living with HIV and persons living with NCDs. The global COVID-19 pandemic has also revealed the need to strengthen national and local capacities to respond effectively to health emergencies. Although COVID-19 remains a threat, supporting the continuity of essential health services to tackle malaria, (AIDS, tuberculosis, and neglected tropical diseases (NTDs), will be critical if Ghana is to attain the SDG3 goals of ending these epidemics by 2030.

Recognizing the singular importance of supporting the country's effort towards the continuity of essential health services during this pandemic, UNDP Ghana with funding from the Government of Japan is implementing a project aimed at 'strengthening community health system to support the continuity of essential services for the vulnerable during and post COVID-19' pandemic.

The project will focus on strengthening the capacities of communities and vulnerable groups such as women, children, persons living with HIV, persons living with NCDs and slum dwellers for the uptake of health services during and post COVID-19 pandemic, whilst strengthening the capacities of health facilities to continue essential service provision and management of COVID-19 and future pandemics.

Key objectives of this project include the provision of relevant medical equipment for five selected Urban CHPS/Health care facilities in Accra and Mobile laboratories for four points of entries (Paga, Aflao, Elubo and Tema).

UNDP Ghana is thus seeking an individual consultant to support the development of technical specifications for the procurement of medical equipment for the selected Urban CHPS and mobile laboratories for the identified points of entries.

# **II. SCOPE OF THE WORK**

The consultant in consultation with UNDP and the Ghana Health Service (GHS) will perform the following tasks.

- Review the equipment needs of the selected Urban CHPS/healthcare facilities and in consultation with relevant staff of the GHS and UNDP provide advice on the best technical solutions to meet the identified needs.
- Draft the technical specifications for the medical equipment to be procured for the Urban CHPS, considering the needs and technical possibilities.
- Work with GHS and NMIMR to assess the laboratory needs at the selected points of entries (Paga, Elubo, Aflao and Tema) and develop the technical specifications for the mobile labs that fits the identified needs and quality including latest technology and price expectations.
- Carry out a market analysis in order to identify the potential suppliers (the leading producers /distributors) of the needed medical equipment and mobile laboratories.
- Assist in preparation of tender documentation and participate in evaluation of the bids.
- Produce a quality assurance report after procurement and installation of equipment; including information about reliability, quality, performance and maintenance requirements of the equipment supplied by the selected vendor.
