UNDP is under no obligation to award a contract to any Bidder as a result of this ITB.</p> <p>1.3 UNDP reserves the right to cancel the procurement process at any stage without any liability of any kind for UNDP, upon notice to the bidders or publication of cancellation notice on UNDP website.</p> <p>1.4 As part of the bid, it is desired that the Bidder registers at the United Nations Global Marketplace (UNGM) website (www.ungm.org). The Bidder may still submit a bid even if not registered with the UNGM. However, if the Bidder is selected for contract award, the Bidder must register on the UNGM prior to contract signature.</p> |
| 2. Bidders found to have a conflict of interest shall be disqualified. Documents Establishing the Eligibility and Qualifications of the Bidder | <p>9.1 The Bidder shall furnish documentary evidence of its status as an eligible and qualified vendor, using the Forms provided under Section 6 and providing documents required in those forms. In order to award a contract to a Bidder, its qualifications must be documented to UNDP's satisfaction.</p> |

Section 5: Schedule of Requirements and Technical Specifications/Bill of Quantities

Background

UNDP Solomon Islands has a significant demand in conference facilities and accommodation services due to frequent organization of workshops, trainings, and conferences in Honiara. It is therefore important that UNDP identify strategic hotels and engage these service providers through competitive bidding process. To achieve cost and process efficiency while ensuring service quality, UNDP Solomon Islands wishes to establish Long Term Agreement(s) (LTA) for a maximum period of three (3) years for Conference Facilities and Hotel Accommodation with service providers specialized in these areas. The successful Service Providers shall be contracted for an initial period of one year, and the contract shall be renewable upon satisfactory evaluation of performance. The LTA prices shall remain fixed for a period of 12 months and subject to any changes after this period upon mutual agreement by both parties.

UNDP Solomon Islands intends to establish Long Term Agreements (LTA's) for conference facilities and accommodation services in Honiara based on 3 bands (High band – 4-star rating and above, Middle band – 3 stars, Lower band – 2 stars and less). UNDP Solomon Islands spends an average total volume of USD 230,000 – USD 250,000 annually for hotel accommodation and conference facilities for UN workshops and meetings. In 2019 the total value of contracts with the hotels was as follows: 2 star – USD 17,700; 3 star – USD 53,730; 4 star – USD 178,500). Due to COVID-19, information on conference/accommodation expenditures in 2020 cannot be considered for annual cost estimations, as most of the activities were cancelled.

A Long Term Agreement (LTA) is a written agreement between UNDP and a supplier that is established for specific goods or services at prescribed prices or pricing provisions for a defined period of time, year, against which specific Orders (call-offs) can be placed at any time, during the defined period and with no legal obligation to order any minimum or maximum quantity. The long-term price arrangement is a nonexclusive arrangement and UNDP has the right to purchase the same or similar goods from other suppliers at its sole discretion as the situation may warrant and provides value for money.

Objective
