### 1. BACKGROUND

### 2. SCOPE OF WORK, RESPONSIBILITIES AND DESCRIPTION OF THE PROPOSED ANALYTICAL WORK

### 3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS:

#### I. Academic Qualifications:

Master's degree in economics, public policy, finance or closely related subjects.

#### II. Years of experience:

- Minimum 5 years of experience in public finance, planning and budgeting processes;
- Expertise and experience in research on climate change financing in Cambodia;

- Experience on analysing gender mainstreaming in development programmes, preferably in sectors relevant to the climate change response;
- An experience related to climate public expenditure reviews in Cambodia or in the region would be an advantage;
- Familiarity with government planning systems;
- Ability to interact with senior government officials;
- Ability to work as a team with strong communication skills;

### III. Competencies:

- Strong interpersonal skills, communication and diplomatic skills.
- Openness to change and ability to receive and integrate feedback.
- Strong analytical, reporting and writing abilities.
- Excellent speaking and presentation skills.

## **4. FINANCIAL PROPOSAL**

This is a Lump sum output-based contract. Therefore, the interested offerors are requested to submit **Final All-Inclusive Price** with cost breakdown.

## **5. EVALUATION**

Offerors will be evaluated based on the Cumulative analysis.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the Offerors who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

### **5. 1. Technical qualification evaluation criteria:**

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification:

Minimum 5 years of experience in public finance, planning and budgeting processes;	30

Expertise and experience in research on climate change financing in Cambodia; An experience related to climate public expenditure reviews in Cambodia or in the region would be an advantage;	30
Experience on analysing gender mainstreaming in development programmes, preferably in sectors relevant to the climate change response;	20
Ability to interact with senior government officials; Fluency in spoken and written English and Khmer;	20
<b>Total Obtainable Score</b>	<b>100</b>

Only the offerors who have attained a minimum of 70% of total points will be considered as technical qualified offerors.

## **5. 2. Financial/Price Proposal Comparison:**

- Only the financial/price proposal of offerors who have attained a minimum of 70% score in the technical qualification evaluation will be considered and evaluated. The total number of points allocated for the price component is 100. Below is the formula used for this evaluation:  
Rating for Financial Proposal = (Lowest Priced Offer / Price of the Offer Being Reviewed) x 100

## **5.3. Selection Method and Award Criteria:**

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

- Responsive/compliant/acceptable, and
- Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula: Total Score = Technical Qualification Score x 70% + Financial Score x 30%
