## I. BACKGROUND

The Government of Indonesia (Gol) has committed to address climate change including risks and vulnerabilities that could have implications to the national development agendas. Up to now, Gol has enacted several climate change policies, i.e RAN-GRK, RAN-API, and NDC. To finance the climate change actions, the government has to ensure that it not only has adequate funding but also to track and monitor the results of the programmes it implements. In addition to addressing the direct challenge of climate change, the Gol also needs to overcome the differential impact of climate change on gender. In Indonesia and other developing countries, many women work in the informal sector who depend on agricultural and plantation products. The changing climate increased the risk of natural disasters such as floods, heat waves and long droughts, which will be a high risk for women because they will lose their livelihoods.

During the two RPJMN periods, climate change and gender mainstreaming (PUG) have been defined as cross-sectoral development strategies. It is hoped that the implementation of PUG integration into the government planning and budgeting cycle can encourage the allocation of development resources to be more effective, accountable and fair in providing benefits to all Indonesian citizens, both men and women.

As an effort to improve accountability and track the budget allocations, the budget tagging system is needed. Several thematic budget tagging themes are gender-responsive budget (ARG) with code (003), climate mitigation budget (004) and climate adaptation (007).

However, there are still various challenges in the implementation of combined-theme budget tagging, particularly in carrying out a gender analysis pathway (GAP) on climate change outputs as the basis for combined-theme budget tagging. To support the implementation of combined-theme budget tagging (gender and climate change), then the development of guidance is needed. In this regard, SDF Project has supported the Ministry of Finance and Ministry of Women Empowerment and Child Protection to develop technical guidance for gender-responsive climate budget tagging.

To ensure the implementation, the consultant will be responsible to pilot the draft **Technical Guidance for Gender-Responsive Climate Budget Tagging** to two Ministries/Institutions. He/She will work together and under the supervision of the Technical Advisor for Development Finance, UNDP and Technical Associate for Public Climate Finance, Sustainable Development Finance (SDF) Project, UNDP Indonesia.

#### II. SCOPE OF WORK, ACTIVITIES, AND DELIVERABLES

The objective of the assignment is for the consultant to conduct the trial of the technical guidance for gender responsive budgeting including facilitating the training to selected ministries on the topic of gender mainstreaming and climate finance.

# Scope of the assignment:

In consultation with the SDF team and the Ministry of Finance as well as the Ministry of Women Empowerment and Child Protection, the Consultant is expected to:

- 1. Pre-trial phase
  - Prepare the detailed work plan and timeline for trial phase and technical assistance, as well as the update and revise the work plan based on comments and inputs from key stakeholders (such as MoF, MoWECP, Bappenas) and UNDP.
  - Assessment and scoring to select priority ministries/institutions for piloting.
  - Facilitate the training on developing GAP and GBS for selected ministries/institutions.
- 2. Trial of the Technical Guidance
  - Assist two selected pilot ministries by using the technical guidance, to exercise using GAP and GBS for climate-related outputs.
  - Produce a report after assisting the pilot ministries.
- 3. Dissemination of the Technical Guidance
  - Finalize the technical guidance after receiving multiple feedbacks from Ministries.
  - Disseminate the final technical guidance.

### **Institutional Arrangement**
