## 2. SCOPE OF WORK, RESPONSIBILITIES AND DESCRIPTION OF THE PROPOSED ANALYTICAL WORK

## 3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS:

### I. Academic Qualifications:

- At least a Bachelor's Degree in agriculture, agro-industry, food technology, environment, development management or other relevant field.

### II. Years of experience:

- At least 5 years' experience working in applied fields, including in capacity building, community dialogue and event management.
- Extensive experience in organizing and facilitating dialogues in various locations and with diverse stakeholders
- Extensive experience working with government, development partners, the private sector and civil society in Cambodia in areas contributing to food systems.

### III. Competencies:

- Teamwork
- Able to work under tight deadlines for planning, conduct and reporting
- Ability to operate independently
- Confident in public speaking, stakeholder engagement and promoting inclusiveness
- Competence in working with online communication platforms in use for the dialogues

#### IV. Language Requirement:

- Excellent written and spoken command of English and Khmer

#### **4. FINANCIAL PROPOSAL**

This is a Lump sum output-based contract. Therefore, the interested offerors are requested to submit **Final All-Inclusive Price** with cost breakdown

#### **5. EVALUATION**

Offerors will be evaluated based on the Cumulative analysis.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the Offerors who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

##### **5. 1. Technical qualification evaluation criteria:**

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification:

Bachelor's Degree or higher in food systems, agriculture, agro-industry, food technology, environment, development management or other relevant field	10
At least 3 years' experience working in applied fields such as capacity building, community dialogue and event management	40
Extent of experience working with government, development partners, the private sector and civil society in Cambodia in areas contributing to food systems	30
Experience in the conduct of applied research, literature review and studies relating to the food system generally or key aspects of the food system	20
<b>Total Obtainable Score:</b>	<b>100</b>

Only the offeror who have attained a minimum of 70% of total points will be considered as technical qualified offeror.

## **5. 2. Financial/Price Proposal Comparison:**

- Only the financial/price proposal of offeror who have attained a minimum of 70% score in the technical evaluation will be considered and evaluated.
- The total number of points allocated for the price component is 100.
- The maximum number of points will be allotted to the lowest price proposal that is opened/evaluated and compared among those technical qualified Offerors who have attained a minimum of 70% score in the technical evaluation. All other price proposals will receive points in inverse proportion to the lowest price.  $[\text{Lowest Price} \times 100 / \text{Other Price under Consideration}] = \text{Points for Other Offerors' Price Component}$ .

## **5.3. Selection Method and Award Criteria:**

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

- Responsive/compliant/acceptable, and
- Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula:  $\text{Total Score} = \text{Technical Score} \times 0.7 + \text{Finance Score} \times 0.3$
