

## Terms of Reference

### Procurement of Office Equipment for setting up Special Management Unit

#### Background

UNODC's Regional Office for South Asia (ROSA) covers Bangladesh, Bhutan, India, Maldives, Nepal and Sri Lanka and has been working closely with Governments of South Asia to counter drugs, crime and terrorism in all its manifestations. Over the years, the Governments of South Asian countries have been active partners in the planning and implementation of UNODC ROSA's Regional Programme for South Asia 2018-2021<sup>1</sup> and local projects. The current project has been developed for the Maldives on the basis of ROSA's vast experience in the area of prison reform particularly in low-income, developing countries, taking account of the key requirements of ownership, sustainability and replicability.

Following previous initiatives towards addressing violent extremism and radicalization risks in Indian Ocean states and South Asian region, UNODC ROSA is committed to supporting capacity-building efforts targeting Maldives Correctional Service (MCS) to improve security within prisons, managing violent extremist prisoners (VEPs) and contributing to prisoners' reintegration and rehabilitation. This activity is funded by the European Union.

UNODC provides technical support to the MCS to develop and implement a customized assessment methodology for the categorization of VEPs. In order to support the government's efforts to categorize VEPs from the general population, UNODC is providing support to the newly built Special Management Unit (SMU), developed in Maafushi Prison to segregate VEPs. This project seeks to realize the following output:

Output 1: Strengthen capacity of Maldives Prison Service to counter and prevent the proliferation of violent extremist ideology.

To this end, UNODC Programme Office for Maldives requires the procurement of the following items for the SMU. Therefore, below items are required from a local vendor / supplier for the implementation of the planned project activities.
