Kindly advise if there would be any quantitative research besides qualitative research work against this RFP	The assignment mainly focuses on qualitative research for identifying the policy advocacy options for integrating Renewable Energy in Ready Made Garments. Some quantitative data may be required in case of technology and financing instrument choices.
2.	Who are the stakeholders for this activity?	Relevant stakeholders could be RMG Buyers (PUMA, H&M etc), Suppliers (RMGs), public sector (MoPEMR, SREDA etc), Private Sector Business Association (BGMEA) and so on.
