	A	Yes, for Pasar Omu and Pasar Sibado, there are some old los/block buildings that must be demolished, including the old foundations. <i>Ya, untuk pasar Omu dan pasar Sibado ada sebagian bangunan los/blol lama yang harus dibongkar termasuk pondasi lama.</i>		

	Q	<p>Is the site visit mandatory by bidder?</p> <p><i>Apakah kunjungan ke lapangan wajib dilakukan oleh peserta lelang?</i></p>
2	A	<p>Site visits are not a mandatory, but UNDP gave opportunities for those who want to visit by contacting the contact person Whisnu Anggono / Budhi Ulaen, Email: whisnu.anggono@undp.org / budhi.ulaen@undp.org, June 14th – June 18th 2021, from 9 AM to 3 PM WITA (GMT+8) in Sigi and Donggala, Central Sulawesi and in order to support local regulation to prevent further spread of COVID-19, UNDP encourage potential proposers who have representative in Palu to attend the site visit. The representatives of potential proposers must have travel permit from their company and health certificate. 	A	<p>The function of the excavator in this project is for land preparation and foundation demolition.</p> <p><i>Fungsi dari excavator dalam kegiatan proyek ini untuk mempersiapkan lahan dan pembongkaran pondasi.</i></p>

	A	<p>1. The locations of the two markets are land owned by the local government and the legality of the land is clear. Development permits will be handled by the Dinas Perdagangan and Dinas Perindustrian offices in each region. 2. 	A	<p>In the BOQ it has been explained, and please pay attention and this can be included in the work preparation component in item of site clearing.</p> <p><i>Dalam BOQ sudah dijelaskan dan mohon diperhatikan dan ini termasuk dalam komponen persiapan pekerjaan di item site clearing.</i></p>
7	Q	<p>How long is the duration of this Market construction?</p> <p><i>Berapa lama durasi pelaksanaan pekerjaan pasar ini?</i></p>

	A	The implementation of the work for the pasar Omu and pasar Sibado is 4 months in parallel after the handover of the land to the contractor. <i>Pelaksanaan pekerjaan pasar Omu dan pasar Sibado adalah 4 bulan secara parallel, sejak serah terima lahan kepada kontraktor.</i>
8	Q	Is electricity in the project area already available or must it be prepared by the contractor? <i>Apakah untuk listrik di area project sudah tersedia atau harus disiapkan oleh kontraktor?</i>
	A	The electricity network at the location already exists (PLN), but for working electricity a new connection or generator is needed and prepared by the kontraktor. <i>Jaringan listrik di lokasi sudah ada (PLN), namun untuk listrik kerja diperlukan sambungan baru atau genset yang mesti dipersiapkan oleh kontraktor.</i>
9	Q	The distribution of electricity usage capacity for each market los/block, is it the same or different? <i>Pembagian kapasitas pemakaian listriknya untuk masing masing los/blok pasar, apakah sama atau dibedakan?</i>
	A	1,200 kwh capacity in each los/blcok and there is no difference. <i>Kapasitas 1,200 kwh di setiap los dan tidak ada perbedaan.</i>

	A	The SKA classification according in the tender document and it is very clear. The certificate of expertise (SKA) is adjusted based on the main expertise position & professional. <i>Klasifikasi SKA sudah sangat jelas disyaratkan dalam dokumen tender. 11	Q	Will the project implementation schedule be based on each location? <i>Apakah jadwal pelaksanaan proyek akan dibuat berdasarkan masing-masing lokasi?</i>
	A	Yes, that is correct. The implementation schedule is made for each location and the implementation of the work for the two market shall be parallel in 4 months. <i>Benar, jadwal pelaksanaan di buat tiap masing masing lokasi dan pelaksanaan pekerjaan untuk kedua pasar tersebut dilakukan secara paralel dalam 4 bulan.</i>

	A	Based on UNDP procurement rules and regulations, UNDP shall not disclose the budget. Therefore, we expect bidders to give us their professional estimate to implement the project.

	A	The annual turnover is calculated based on the total revenue of a company as stated in financial report. In order to calculate the average annual turnover for the last 3 years, the company shall know the total revenue in 2018, 2019 and 2020.
