I. BACKGROUND / PROJECT DESCRIPTION

The United Nations Secretary-General set out the global framework for the United Nations' urgent socio-economic support to countries in the face of COVID-19 as one of three critical components of the UN's efforts to save lives, protect people and rebuild better, alongside the health response led by the World Health Organization (WHO) and the humanitarian response, as detailed in the UN-led COVID-19 Global Humanitarian Response Plan.

The socio-economic response framework consists of five streams of work — an integrated support package offered by the United Nations Development System to protect the needs and rights of people living under duress of the pandemic, with particular focus on the most vulnerable countries, groups and people who risk being left behind. The five streams of work that constitute this package include: **1.** Ensuring that essential health services are still available and protecting health systems; **2.** Helping people cope with adversity, through social protection and basic services; **3.** Protecting jobs, supporting small and medium sized enterprises and informal workers; **4.** Supporting the macroeconomic response and multilateral collaboration; and **5.** Promoting social cohesion and investing in community-led resilience and response systems.

It is against this backdrop that the United Nations System in The Gambia developed the UN Socio-Economic Response Plan to implement this framework at the country level over the next 12 to 18 months. Already, significant resources in the UN's existing portfolio of sustainable development programmes across all the Sustainable Development Goals (SDGs) have been adjusted and expanded towards COVID-19 related needs. Despite these repurposing and reprogramming efforts, given the scale of the socio-economic impact, additional resources and programmes will be required to fully address the pandemic.

It is in this regard that the UN seeks to engage the services of a consultancy firm to support UN Agencies in developing proposals to submit to the upcoming windows of opportunities with the below outlined timeline.

The Fund's Three Windows of Finance

- **Window 1:** Finances governments and communities to supress COVID-19 transmission. It provides low- and middle-income countries with access to quality treatment, IPC and prevention measures through multi-sectorial aid.
- Window 2: Mitigates the socio-economic impact and safeguards people and their livelihoods through support for social protection mechanisms. It aims to ensure that the burden of response and recovery are not disproportionately carried by the most vulnerable.
- **Window 3** on Recover Better ensures the achievement of SDG targets by 2030, despite the current and future shocks.

2021 Calls for Proposals

2021 (Call 4) Extending the Safety Net

This call for proposals will further focus on mitigating the social and economic crises caused by COVID-19. Proposals will mainly fall under Window 2 of the Fund, as described above. Further details on this call will be developed in view of the evolution of needs as a result of the pandemic

2021 (Call 5) Building Resilience: Build back better

Further details on this call will be developed in view of the evolution of needs as a result of the pandemic.

2022 Calls for Proposals

2022 (Call 6) Leveraging the Joint SDG Pipeline

This final call for proposals, which will fall largely under Window 3, will create a pipeline of programmes and projects to feed into the Joint SDG Fund. Remaining funds will be allocated against the Joint SDG Fund Pipeline, confirmed by the SDG Joint Fund Technical Committee. Funds will be technically moved to the Joint SDG Fund and managed from there. Window 3 focuses on aiding resilience and recovery and it aims to ensure the achievement of SDG targets by 2030, despite the current and future shocks.

The United Nations COVID-19 Response and Recovery Multi-Partner Trust Fund (UN COVID-19 MPTF or the Fund) gives the Designate of the UN Secretary-General for the COVID-19 MPTF (the Designate), in consultation with the Fund's Advisory Committee, the ability to allocate funds to priority needs, encourage early donor contributions, and allow for rapid response to unforeseen demands. This fund was launched by the Secretary-General to help scale-up integrated UN support to low- and middle-income programme countries, as they respond to this crisis and recover from its socio-economic shocks. It is designed as a humanitarian to development nexus fund.

II. SCOPE OF THE WORK

The assignment will be coordinated by the UN Resident Coordinator's Office with support from UNDP as technical lead and consultations with the United Nations Country Team in The Gambia. The consulting firm will also consult relevant ministries, departments and agencies of the Government of The Gambia as necessary as well as other relevant institutions. The tasks involved will include coordinate and consolidate the inputs from UN

Agencies to submit quality proposals in a timely manner in the desired window of proposals.

A gender and human rights based approach (HRBA) together with results based management (RBM) is to be included in the development of the proposals, to ensure that they meet the needs of the most vulnerable and most at risk, including women, youth, elderly, rural versus urban population, persons with disabilities, migrants and returnees, ensuring that no one is left behind.

• Minimum of ten (10) years professional experience in project management and a very good understanding of project/programme development.

c. Competencies:

 Prior demonstrated experience in developing programmes for development partners within a developing country context.

d. Language and other skills:

- Excellent knowledge of English, including the ability to set out a coherent argument in presentations and group interactions.
- Oral and written communication: Capacity to communicate fluently with different stakeholders (development partners, government authorities, local communities, project staff); and reflect results in comprehensive report.
- Computer skills: full command of Microsoft applications (Word, Excel, PowerPoint) and common internet applications will be required.

 - b. Financial Criteria weight is 30%
