1. BACKGROUND

3. REQUIREMENTS FOR EXPERIENCE AND QUALIFICATIONS:

I. Academic Qualifications:

At least Master's degree in natural resource management, environment, public administrative for related field.

II. Years of experience:

- At least 10 years' progressive experience in planning and managing large-scale NRM oriented government programs;
- At least 8 years' experiences in development of PA strategy and plan;
- At least 8 years' experience in development of measures/tools instruments for PA;
- At least 8 years' experience in developing PA management plan;
- At least 8 years' experience in review of mechanism, tools and guidelines to mainstream biodiversity conservation and ecosystem services;
- Proven track record in similar assignments;
- Experience with GEF and/or other UN assisted projects.

III. Competencies:

- Strong analytical skills and ability in development of strategy, plan; policy and frameworks.
- Strong skill in managing large-scale NRM;
- Excellent English written with analytic capacity and ability to synthesize project outputs and relevant findings for the preparation of quality project reports.
- Ability to understand new terminology and concepts easily and to synthesize information from different sources into a coherent project document.
- Skill in achieving results through persuading, influencing, and working with others.

4. FINANCIAL PROPOSAL

This is a <u>Lump sum output-based contract</u>. Therefore, the interested offerors are requested to submit **<u>Final All-Inclusive Price</u>** with cost breakdown.

5. EVALUATION

Offerors will be evaluated based on the <u>Cumulative analysis</u>.

- Technical Qualification (100 points) weight; [70%]
- Financial/Price Proposal (100 points) weight; [30%]

A two-stage procedure is utilized in evaluating the proposals, with evaluation of the technical proposal being completed prior to any price proposal being compared. Only the price proposal of the Offerors who passed the minimum technical score of 70% of the obtainable score of 100 points in the technical qualification evaluation will be evaluated.

5. 1. Technical qualification evaluation criteria:

The total number of points allocated for the technical qualification component is 100. The technical qualification of the offeror/individual is evaluated based on following technical qualification:

Only the offerors who have attained a minimum of 70% of total points will be considered as technical qualified offerors.

5. 2. Financial/Price Proposal Comparison:

• Only the financial/price proposal of offerors who have attained a minimum of 70% score in the technical qualification evaluation will be considered and evaluated. The total number of points allocated for the price component is 100. Below is the formula used for this evaluation:

Rating for Financial Proposal = (Lowest Priced Offer / Price of the Offer Being Reviewed) x 100

5.3. Selection Method and Award Criteria:

The award of the contract should be made to the individual consultant whose offer has been evaluated and determined as:

- Responsive/compliant/acceptable, and
- Having received the highest score out of a pre-determined set of weighted technical and financial criteria specific to the solicitation. The total score for each offeror will be calculated independently by this formula: Total Score = Technical Qualification Score x 70% + Financial Score x 30%
