## **ANNEX 1: SCHEDULE OF REQUIREMENTS**

### **TERM OF REFERENCE RENTAL WAREHOUSE**

#### **1. Background**

The objectives of the overarching strategy of Indonesia's HCFC Phase-out Management Plan (HPMP Stage-II) is (1) to facilitate Indonesia's compliance with the control targets for HCFC consumption post 2015 with minimal impacts on the national economy, on environment, on safety, and on occupational health; and (2) to implement a combination of interventions such as technology transfer investments, policies and regulations, technical assistance, training and capacity-building, awareness and education and monitoring and management in the HCFC consuming sectors, contributing to achieve sustainable reductions and phase-out of HCFC consumption.

HPMP Stage-II has been prepared together by UNDP and the Ministry of Environment and Forestry (KLHK) to achieve Indonesia's 2020 targets and consumption reduction up to the year 2023 over and above the MP requirements as per Decision XIX/6. UNDP is focusing on the phase-out of HCFC from servicing sector, technical assistance to firefighting sector and policy and regulations enforcement training. The plan also includes activities that build on already implemented HPMP Stage-I activities and steps to promote sustainable low GWP options in RAC sector in the country.

Upon the implementation of HPMP Stage-II, Indonesia will cumulatively phase-out 102% of the starting point that is defined in Appendix 1-A of the Agreement between Indonesia and the Executive Committee. The total GHG emission impact for the components of HPMP Stage-II implemented by UNDP is equivalent to 1.76 Million tons of CO<sub>2</sub> reduction.

The main challenges identified in HCFC phase out are the availability of cost effective, environment friendly and efficient alternatives. Under the HPMP stage-II, the focus is more on long term environmental and occupational sustainability while selecting alternative substances and technologies. Thus, the selection of alternative substance is governed by the factors such as favorable physical and chemical properties for the concerned application, being inert and stable, compatible with existing materials, preferably not flammable and toxic, with zero ODP and low GWP and easily available.

#### **2. Project Objectives/Scope**

Under direct supervision of UNDP Operations Unit, the Contractor is the company with performance of a professional storage service provider.

**The specific requirement for the storage of equipment should be:**

1. Indoor storage.
2. Maintain good security system of the area for 24 hours. Safety with Alarm and CCTV-IP.
3. Climate controlled unit - control of humidity (in-room temperature = 25°C)
4. Maintain cleanliness of the area and provide regular cleaning service (minimum 1X per week) to keep inside the warehouse clean and tidy.
5. The monthly cost should include Insurance that cover any damage during rental period, fumigation (1X per month), pest control (1X per month), and electricity (no minimum requirement).

6. Loading & Unloading, Transportation include insurance for one time shipping from current warehouse in Pluit Jakarta area to new warehouse.
7. The total size of storage to be rent is 280 m<sup>2</sup> (for storage, for Testing/Training area & loading/unloading or packing/unpacking during Testing/Training)
8. The warehouse should be able to store all of the following equipment as describe in **Lisf of Equipment to Store**.
9. Free parking fee at the warehouse area, for KLHK, UNDP, and Beneficiary.
10. Provide pallet to cover the storage floor when necessary
11. Provide simple wrapping (not sticky wrapping) service when required with plastic to cover the stored items/equipment
12. The warehouse should be located Jakarta area with easily accessible for trucks.

### **3. Period of Performance**

UNDP is planning to enter into a short-term contract with the Contractor for **period of 6 months**, starting **from 25 July 2021 to 24 January 2022**, with possibility of extension as necessary. Performance evaluation of the contractor will be made after 6 months.

### **4. Payment Method**

Payment will be made monthly within 30 days of receipt of the Contractor's invoice, and UNDP is exempted from all direct taxes and custom duties.
