LNOB is grounded in the UN's normative standards and it is our duty to address LNOB across all the pillars of our work. While, there has been a longstanding recognition of the importance of realising our commitments to LNOB through our programming and advocacy, it is relatively recent that LNOB tools/approaches have also come to address our commitments to inclusion, equality and non-discrimination in our internal processes. As stated by the Enabling Environment Guidelines (UN 2019):

As a means to support the UN, both in its internal and external efforts, to hold true to the principle of LNOB, there is a need to provide the UN Country Teams (UNCTs) with improved capacity, evidence and tools to foster coordinated, coherent and collective action across all pillars of its work (programmatic, normative, operational). #### **5. FINANCIAL PROPOSAL**

## 1. **Project Description**

The UN's commitment to leaving no one behind (LNOB) requires combatting and addressing the root causes of discrimination and rising inequalities within and across countries. LNOB is grounded in the UN's normative standards and it is our duty to address LNOB across all the pillars of our work. While, there has been a longstanding recognition of the importance of realising our commitments to LNOB through our programming and advocacy, it is relatively recent that LNOB tools/approaches have also come to address our commitments to inclusion, equality and non-discrimination in our internal processes. As stated by the Enabling Environment Guidelines (UN 2019):

"The effectiveness of the United Nations and the success of our efforts depend on reaping the gains in efficiency and productivity that come from diversity and gender parity. Sustainable change depends on transforming our organizational culture so that it fosters a safe and respectful environment in which all have equal access to opportunities. The United Nations is the principal international standard-setting institution and bears a special responsibility to lead by example and demonstrate the core values of equality, human rights and non-discrimination."

#### 2. Scope of the work

The responsible party will work with the Resident Coordinator's Office (RCO) Nepal, DCO Bangkok, Pulse Labs and other RCOs/UN agencies as required, to draft a detailed concept note for the conceptualization and detailing of an LNOB Assessment and Monitoring Platform to be piloted across three to five countries in the region. The platform should increase efficiencies and reduce the work burden by automatically generating certain percentage of result fulfillment for LNOB reporting requirements such as the scorecards and by identifying linkages between different processes, for example how the gender and disability scorecard indicators link and complement one another. The platform should collect and analyse data automatically throughout the year, thus also reducing the end-of-year reporting burden and establish a quicker feedback loop, allowing for modification throughout the year for example in relation to communication or programming, thus fostering a more inclusive, responsive and flexible organisation. The Platform should also facilitate the identification of linkages and enabling factors between indicators of the accountability scorecards. The platform is to go beyond looking at the Scorecard Indicators identifying patterns that show possible gaps in our internal and external efforts in regards to our commitment to the principle of LNOB, and potentially providing data driven solutions to realise the preferred future.

## 3. Responsibilities

The contracted party will be responsible for developing a detailed concept note for LNOB Assessment and Monitoring Platform in close collaboration with RCO Nepal, DCO Bangkok and relevant UN Global Pulse Labs.

- Review relevant documentation in relation to UNCT-wide accountability on LNOB including the UNCT Accountability Scorecards on Gender Equality, Disability Inclusion and Youth in order to incorporate the necessary frameworks and indicators into the concept note and methodology.
- Map the various UNCT reporting platforms and reporting timelines to establish the necessary linkages to the new LNOB assessment and monitoring platform.
- Hold discussions with relevant personnel of RCO Nepal, DCO Bangkok and Pulse Labs, as well as of other RCOs and UN agencies as required, in support of informing the concept note and ensuring that it is developed to meet the needs of UNCTs across the region.
