Development Mobile Plant Mercury-Free Gold Processing Equipment for Alluvial Ore at Kabupaten Kuantan Singingi

I. Background Information

GEF, the United Nations Development Programme (UNDP), the Ministry of Environment and Forestry (Kementerian Lingkungan Hidup dan Kehutanan or KLHK), and Agency for Technology Assessment and Application (Badan Pengkajian dan Penerapan Teknologi or BPPT) have been working together to initiate and implement Global Opportunities for Long-term Development – Integrated Sound Management of Mercury in Indonesia’s Artisanal and Small-scale Gold Mining (GOLD-ISMIA) project in Indonesia.

The project is meant to reduce/eliminate mercury releases from the Indonesian ASGM sector by;

- (i) Strengthening institutions and the policy/regulatory framework for mercury-free ASGM,
- (ii) Increasing the access of mining communities to finance to enable the procurement of mercury-free processing technologies,
- (iii) Increasing the capacity of mining communities for mercury-free ASGM through the provision of technical assistance, technology transfer and support for formalization, and,
- (iv) Raising awareness and disseminating best practices and lessons-learned on mercury phase-out in the ASGM sector.

Targeting the project objective which is increasing the capacity of mining communities for mercury-free ASGM through the provision of technical assistance and technology transfer, it is stated in the project document that the project must be able to establish 1 mercury-free ore processing training plant and equipped 5 small mobile plant mercury-free gold ore processing plant. Ministry of Environment and Forestry and Agency for the Assessment and Application of Technology (BPPT - Badan Pengkajian dan Penerapan Teknologi) as our implementing partners have developed and established a mercury-free ore processing training plant in 7 provinces in Indonesia. Thus, the project can adopt the Detail Engineering Design (DED) of those gold processing plants for establishing project processing plant at project site.

The project is working at two type of gold deposit potentials which are primary gold deposits and secondary or alluvial gold deposits. The GOLD-ISMIA project has provided a prototype of small-mobile plant mercury-free gold processing equipment for primary gold ore to be implemented to miners. The practice of using mercury in alluvial gold processing arose out of the fact that the manual washing process by pan for the sluice box concentrate could not get rid of the black sand (iron-sand) and the use of magnets to separate iron sand from concentrates remains lacking in efficiency thus miners use mercury to capture free gold granules. Consequently, alluvial gold ore miners activities also contribute to the release of mercury into environment. Thus, a prototype of small-mobile plant mercury-free processing equipment for alluvial gold ore is necessary to be established and implemented to miners. This prototype is required to be designed in laboratory, built it and tested it directly to mining site, giving miners the opportunity to observe results first hand and learn how to obtain results. Furthermore, resulting a DED that can be adopt by miners in order to reduce mercury use by at least 5 metric tonnes/year starting in year three (3) of the project, which over the life-span of the project will result in a mercury release reduction of at least 15 tonnes.

II. Objectives

1. Fabricate the Mobile Plant Mercury-Free Gold Processing Equipment for Alluvial Ore. This is a series of mercury-free gold processing equipment for alluvial ore in a movable container where the processing until gold concentrate is obtained is carried out at the mine site, and the refining process is carried out in a storage container. Carry out the activity to install and to commission the Mobile Plant Mercury-Free Gold Processing Equipment for Alluvial Ore
2. Carry out training the usage of the equipment (training expense for the miners will be facilitated by the Project Management Unit) .

III. Location

The installment will be located at Logas Village, Singingi District, Regency Kuantan Singingi, Riau Province.

IV. Scope of Work

1. The selected company is required to carry out the Mobile Plant Mercury-Free Gold Processing Equipment for Alluvial Ore with the capacity in accordance provided specification.
2. The selected company must provide and implement a quality management system (QMS) ISO 9001, Occupational Health and Safety Assessment Series (OHSAS) ISO 45001 and Environmental Management System (EMS) ISO 14001.
3. The selected company must do the installation work until the condition are ready for running testing.
4. The selected company must provide user manual for each equipment in Bahasa.
5. The selected company must Install the equipment at the designated location.
6. The selected company must conducted the commissioning which attended by 3 person from BPPT (1 time with duration 5 days) for Mobile Plant Mercury-Free Gold Processing Equipment for Alluvial Ore. All necessities and accommodation for representatives from BPPT during the commissioning are facilitated by selected company using SBU KEMENKEU rate.
7. Warranty

The selected company should provide after sales guarantee, such as;

 - Warranty on parts and maintenance free for minimum period of 1 (one) year upon complete installation, commissioning and training. During the warranty period in the event of damage due to human error, selected company provides a guarantee of repair or replacement of parts.
