B. BACKGROUND AND PROJECT DESCRIPTION

The Kingdom of Lesotho features rich ecosystems and high species diversity, which provide critical ecological infrastructure, and offer many goods and services to rural communities that make up 70 to 80 percent of the population. The Government of Lesotho aims to support these populations to continue to derive sustainable benefits from its natural resources, particularly in the areas of medicinal, aromatic and ornamental species. It will do this by strengthening the enabling framework and capacity for implementing the Nagoya Protocol on Access to Genetic Resources and the Fair and Equitable Sharing of Benefits Arising from their Utilization (in short "the Nagoya Protocol").

The Nagoya Protocol is a supplementary agreement to the Convention on Biological Diversity (CBD). It provides a transparent legal framework for the effective implementation of one of the three objectives of the CBD: the fair and equitable sharing of benefits arising out of the utilization of genetic resources. The Kingdom of Lesotho has been a party to the Nagoya Protocol since February 2015.

Certain aspects of access to genetic resources and benefit sharing (ABS), and traditional knowledge are addressed in some of Lesotho's policy instruments and plans that call for conservation of biodiversity in support of sustainable development, but a more coherent and comprehensive approach is required. In this context, Lesotho seeks to create an enabling environment and equip stakeholders with the skills, capacity, and resources to sustainably harvest, add value to, manage, conserve, and benefit from genetic resources.

As the largest operational and financial UN player in the field of ecosystems and biodiversity, the United Development Programme (UNDP) is widely recognized as a global leader in supporting governments to sharpen policy, access finance and develop capacity for the management of biodiversity and ecosystems for sustainable development and poverty eradication. UNDP in Lesotho provides support to build resilience at every level to help achieve the Sustainable Development Goals. UNDP provides assistance in the areas of poverty reduction, transparent, accountable and effective governance, and sustainable management of natural resources.

UNDP is supporting the Government of Lesotho (GoL) through the Ministry of Tourism, Environment and Culture (MTEC) to develop a project, supported by the Global Environment Facility (GEF), that promotes conservation, sustainable use, and benefit-sharing, as well as research and development of natural products from such resources. This support is at an advanced stage, with a draft Project Document (ProDoc) in place. The ProDoc is proposing the following three interrelated components that will enable Lesotho to achieve above-mentioned ABS objectives:

- Strengthened institutional capacity and regulatory framework to support the implementation of the Nagoya Protocol on ABS.
- Sustainable use and conservation of selected commercially important medicinal plants for the development of ABS products for the pharmaceutical sector.
- 3. Gender mainstreaming, knowledge management, and monitoring and evaluation.

Context of the Required Service for the assignment

UNDP is seeking a national consultant who will support updating and finalizing the mentioned ProDoc and CEO endorsement request document as per the donor's (GEF) feedback on the ProDoc for the proposed project "Promoting conservation, sustainable utilization and fair and equitable benefit-sharing from Lesotho's Medicinal Plants for improved livelihoods."

E. SCOPE OF WORK AND SPECIFIC TASKS

The Consultant will be responsible to support the international consultant/Project Development Specialist (PDS) leading finalization of the project document for the project "Promoting conservation, sustainable utilization and fair and equitable benefit-sharing from Lesotho's Medicinal Plants for improved livelihoods."

He/she will be responsible for undertaking desk-top research and consolidating inputs needed for updating and finalization the ProDoc and CEO Endorsement Request, with all mandatory and project specific annexes and supporting documentation. The national consultant will be expected to support with the following tasks as it may be necessary and/or additional information that may be needed for updating and finalization of the ProDoc:

- Compile an ethnobotanical, antimicrobial, phytochemical and efficacy profile of medicinal plants of Lesotho.
- Use above profile to identify and prioritize medicinal plants of Lesotho with a high potential for successful commercialization and research and development.
- Identify current commercial activities on medicinal plants of Lesotho including identifying plants currently traded in local and international markets, mapping market chains, market actors, products and industries.

- Compile information on current activities on research and development of medicinal plants of Lesotho including identifying targeted plants and potential industries.
- Undertake capacity needs assessment of relevant institutions as well as private sector to carry out research
 and development on medicinal plants of Lesotho including required expertise, infrastructure and
 equipment.
- Identify challenges prohibiting successful commercialization and research and development and strengthened value-chains of medicinal plants of Lesotho.
- Identify opportunities and make recommendations on measures to improve commercialization and research and development of medicinal plants of Lesotho. as well as strengthening of the value-chains.
